
3. 11 (Eleven) Blank tender forms were issued up to 12-04-2017 along-with details of work and the amount of security deposit shown in the bidding documents. Out of which 08 (Eight) envelopes were received on 13-04-2017 within the fixed time in which 08 (Eight) Technical Proposals and 09 (Nine) Financial Proposals were found.

4. All Technical Proposals were opened in presence of the above committee members and the concerned parties or their representatives, which have been examined case to case.

5. After finalizing the technical proposals, 08 (Eight) parties (bidders) have been qualified and those 08 (Eight) party's (bidder's) financial proposals were opened. From 08 (Eight) Financial Proposals (envelopes), 09 (Nine) filled tender forms were found.

6. After opening the Financial Proposals, the members of the committee have examined each & every proposal and found some Pages of Tender form un-signed, overwriting and cutting as well as rates not quoted in words by the various parties, which have been exempted by the Committee.

8. However, the Party-wise & route-wise details of the lowest bidders are shown as under.





In view of the above details, the committee considered the comparison of the Market rates for Transportation of Wheat from All PRC's / WPC's of Jamshoro District to Bolhari / Kotri PRC / Private Hired Godowns and increase in labor charges of loading / unloading @ Rs.22/- and also enhancement of additional tax of SST @ 8 % recoverable from the transporters.

Beside, the lowest rates offered by the parties on the other work has also been considered and discussed at length and after discussion, the members of the committee has been recommended the lowest offered rates of above named parties / firms as indicated in the Para 8 above which may be accepted & approved.
