With the permission of competent authority, the tender for procurement of above said items for the year 2017-18, by adopting single stage-one envelope procedure was invited through information Department Government of Sindh, that appeared in Daily National Newspapers Daily the News, Dated: 26-02-2018 Daily Express Dated: 25-02-2018 & Daily Sobh Dated 26-02-2018 upto the closing date: 19-03-2018, total (03) firms purchased the tender documents and all the three firms responded and submitted sealed tenders.

The tenders were opened by the procurement committee in the presence of participating bidders or their representative on 19-03-2018 and rates item wise quoted by each firm was announced before the representatives.

After the opening of the tenders the chair directed to the Deputy Director Fisheries District Khairpur to scrutinize the tenders in the light of eligibility criteria i.e registration of firms, Income tax/GST, experience etc and prepare tender wise comparative statement showing each item along with offered price & bring before the procurement committee along with tender documents up to 4.pm.

The 2nd meeting of the committee held at 4.pm. The committee gone through the eligibility criteria, comparative statement and took following decisions.

- 1) The rate offered by M/S Salah brothers for tender No.1(Fish seed) is recommended being first lowest.

- 2) The rates quoted for various items under tender 2 printing & publication is recommended being first lowest as under,
- i) For item No.1 rate offered by M/S A.S Traders.
 - ii) For item No.2 rate offered by M/S Pakistan furniture.
 - iii) For the item No:03 to 14 rates offered by M/S Salah Brothers.
- 3) The rate quoted for repair of office furniture under tender No:03 by M/S Pakistan traders & furniture is recommended being 1st lowest.
- 4) The rates quoted for repair of water pumps tender No:04 by M/S Pakistan furniture traders is recommended being 1st lowest.
- 5) The rate for item No:05 by M/S Salah Brothers was recommended being 1st lowest.
- 6) The rate quoted for others misc items S.No:01 to 10 under tender No:06 offered by M/S Salah Brothers, where as the rate offered by M/S Pakistan furniture traders for item No:09 is recommended being 1st lowest.

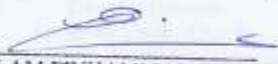
