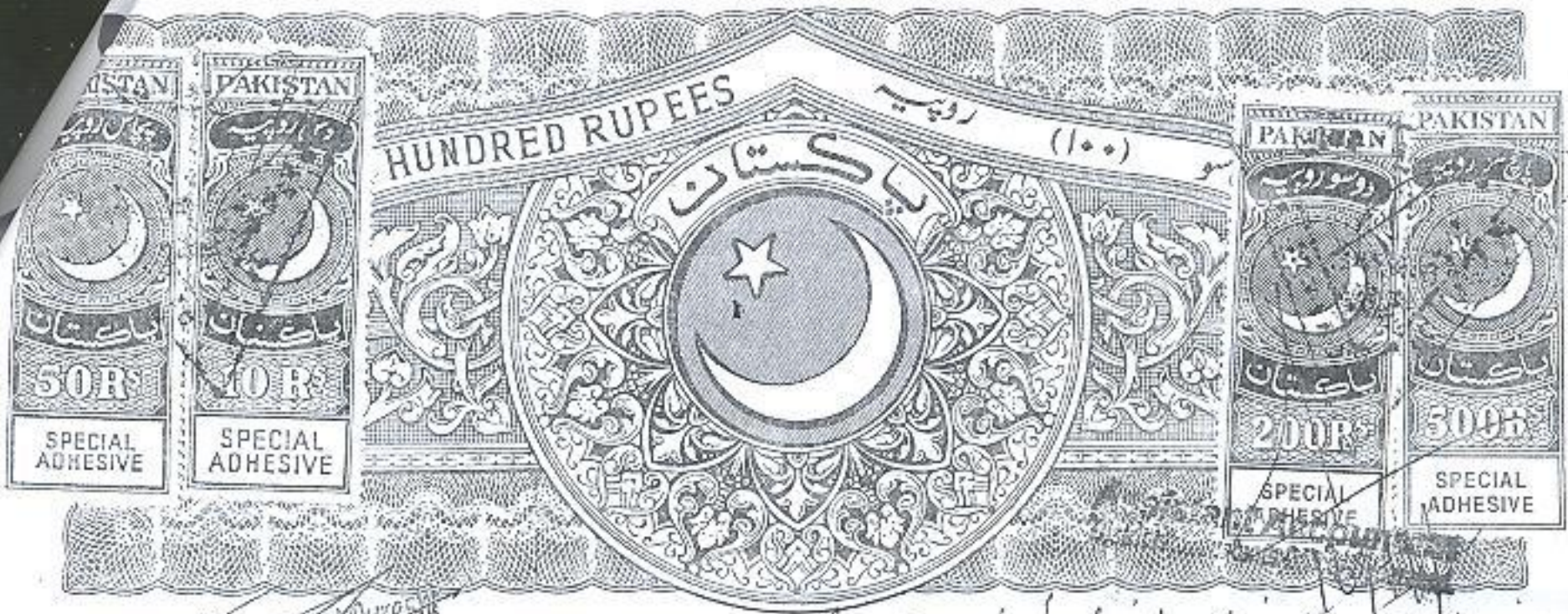

called the "Contractor" which expression shall include their successors, legal representatives of the second part.

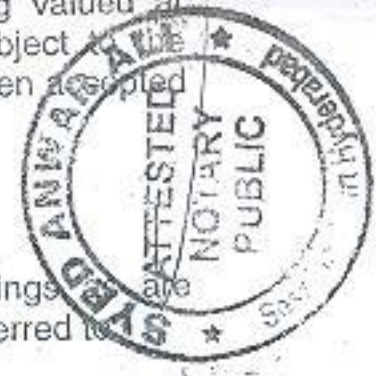
