
M/s Al-Basit Enterprises offered the rates which were lower than minimum wage rate set by Government of Sindh of unskilled workers. Hence their offer was rejected.

- Procurement Committee **approved and accepted** the offer of M/s. Master Multi-Tech for the above tender being lowest and best evaluated bid.


