

- The sealed envelopes, marked as "**Technical Proposal**" were opened by the Procurement Committee in front of the representative of the bidder and the proposals were evaluated in accordance with the SPPRA rules.
- The procurement committee decides that the matter will be discussed and finalized in its next meeting which was scheduled to be held on 7th April, 2017.
- Accordingly a meeting of the procurement committee was held under the chairmanship of Director, Bureau of Supply & Prices, in his office on 7th April 2017 at 03:00 PM.

- All the members of the procurement committee attended the meeting.
- After going through the contents of the Technical Evaluation Sheet, the committee unanimously decide that as the two bidders namely M/S. Sashun International & M/S. Shahbaz Enterprises does not fulfill the required criteria, therefore their financial proposal will return unopened and agreed to award the contract to the best evaluated bid i.e., M/s Nazeer Enterprises, as he fulfills all the required criteria.
- However, it was decided that before awarding the contract, two quotations must be obtained from open market to evaluate the price quoted by the successful bidder.
- All the committee members signed the documents.
- The meeting concludes with a vote of thanks to end from the chairs.
