A meeting was held under the chairmanship of the Director, BSP/ Controller, W&M, Agriculture, Supply & Prices Department, Sindh for opening of Technical and Financial Proposal for the procurement of furniture & fixture and Plant & Machinery under ADP Scheme 21 Bureau of Supply & Prices for H.Q. Karachi on 13th & 20th April, 2017 at Karachi. The meeting was also attended by the members of procurement committee and the representatives of the bidders.

- The meeting started with the recitation of verses from the Holy Quran.
- The chairman welcomed the participants.
- The convener informed that the advertisement for procurement for the procurement of furniture & fixture and Plant & Machinery under ADP Scheme 21 Bureau of Supply & Prices was published in leading daily Newspapers are vide. INF-KRY No. 1458/17, dated: 26-03-2017.
- The meeting was informed that **three (03)** bidding documents were sold for **Furniture & Fixture** and **three (03)** for **Plant & Machinery** respectively.

- The sealed envelopes, marked as “**Technical Proposal**” were opened on 13th April, 2017 by the Procurement Committee in front of the representative of the bidder and the proposals were evaluated in accordance with the SPPRA rules.
- The Procurement Committee decides that the “**Financial Proposal**” will be opened on its next meeting which was scheduled to be held on 20th April, 2017.
- Accordingly a meeting of the Procurement Committee was held under the chairmanship of Director, BSP / Controller, W&M, in his office on 20th April, 2017 at 03:00 P.M to open and discuss the Financial Proposal for furniture & fixture and Plant & Machinery.
- All the members of the Procurement committee attended the meeting.
- During the scrutiny of technical proposal, it has been observed by the Procurement Committee that, the M/s Shahzaib Enterprises has no experience of public sector as per his statement in the technical documents.
- The forum was informed that a committee has been constituted, comprising of Aziz ur Rehman Zahid Soomro, Deputy Controller (B – 18), Chairmen, Mr. Iftekhhar Ahmed Memon, Assistant Controller (B – 17) and Mr. Sarfaraz Ahmed, Inspector (B – 16), members to evaluate the specification and quality of furniture & fixture of the interested bidders.
- The above said committee inspected the samples provided by M/s Nazeer Enterprises are found better in comparison to that of M/s H.U Engineering, whereas, M/s Shahzaib Enterprises has failed to provide the samples.
- After going the contents of the Technical & Financial Evaluation Sheet, the committee agreed to award the contract to the best evaluated bid i.e. M/s Nazeer Enterprises for Furniture & Fixture and Fax Machine, M/s Multi Tech for Photocopier as they fulfill all the required criteria.
- All the committee members signed the documents.
- The total amount of Rs. 525,000/- and Rs. 756,000/- for procurement of sofa set and visitors chairs normal has been proposed as per availability of budget.
- The meeting concludes with a vote of thanks to end from the chairs.
