






- i. The tenders purchased by the bidders up to date: 02-06-2016 at 12:00 PM were opened before the procurement committee in presence of representatives of participants.

- iii. The bids were opened on 02-06-2016 (at 3.00 PM) before the Procurement Committee.

4. The committee was informed that 06-Nos bidders have purchased the bidding documents for all the 02 works up to date: 02-06-2016 (12.00 P.M) and 06-Nos have submitted the bids on 02-06-2016 up to 2:00 PM in the office of the Executive Engineer, Provincial Buildings Division No.III, Karachi.


