



# 'Alternate Dispute Resolution entre dispensing speedy justice'

**HAWALPUR:** District Sessions Judge Chahammad Tariq Javid said the Alternate Dispute Resolution (ADR) centre-under leadership of Lahore High Court Chief Justice Syed Anwar Ali Shah-had been providing speedy relief to grieved parties, with their mutual consent. While talking to media persons on Thursday, the judge

said in the ADR centre, parties resolve issues through mutual dialogue and the method had provided positive results.

The district judge said that efforts were made to convince the parties in the ADR centre to agree upon a solution for their disputes so that they do not grow into larger conflicts and family feuds.

He told the media to highlight the importance and services of Alternate Dispute Resolution (ADR) centre.

Muhammad Tariq Javid told the media that 134 cases had been referred to the ADR Centre, out of which 97 had been decided and 14 were under mediation; while the rest of the cases could not be resolved for a variety of reasons.

Additional Sessions Judge Arif Hameed Sheikh, senior civil judges Mazhar Gillani, Intikhab Alam and other civil judges were also present at the occasion.
