Recommendation: (1) The bid of M/s. Saeed Ahmed declared as rejected due to non compliance of bid security.

(2) The Bid of M/s. Cafe Gulabad & M/s. Cosmos Enterprises are responsive.

(3) The bid of M/s. Cafe Gulabad with cost of Rs.140 per meal (as per Jail Manuel) is lowest evaluated responsive bid and also meeting the requirement of IG Prisons Sindh circulate as referred above.
