3. At the outset, the Chair welcomed the participants to the meeting. The Agenda was formally presented by Deputy Director (HQ&C)/ Member-Secretary. The Chair briefed the participants that since many years, Sindh has been facing disasters in the form of floods and rains, which have resulted in huge losses of lives and infrastructure. To combat such situations, the government has been providing immediate relief by making emergency procurements. However, like previous year, in order to ensure transparency besides encouraging competitive procurement, PDMA intends to strengthen its stocks by inviting wide scale competition in the form of inviting tender. It was further approved that the main purpose of this meeting was to analyze and finalize as to:

- (i) What stock is required to be procured?
- (ii) How much stock is to be procured? and
- (iii) How to procure?


4. The Chair also stressed upon the need to ensure observance of SPP Rules-2010. Then after, a draft bidding document was placed before the PC, which was examined and discussed at length. After deliberations, following decisions were taken:


- i. Procurement of relief goods as per "Annexure-A" with specification and quantity mentioned therein was minutely examined and mutually agreed upon.
- ii. The bidding documents was also minutely examined and partially amended by the PC. The PC unanimously finalized and agreed upon the amended bidding document which may be perused at "Annexure -B".
- iii. The draft Tender Notice was also examined and unanimously approved by PC.
- iv. The PC decides the dates as under:
 - a. Date of publication of Tender Notice: 14.04.2015 (subject to timely submission in Information Department.





- b. Last date of collection of bid documents: 30.04.2015 till closure of business hours.
- c. The last date of submission of bid: 04.05.2015 upto 1300hrs.
- d. Date of opening of tender: 04.05.2015 at 1600hrs.
- v. The bid documents along with the Tender Notice shall also be uploaded on SPPRA website besides uploading it on PDMA's website.
- vi. The tender fee was finalized at Rs.5000/- non refundable. The fees so decided was to be utilized for services of co-opted members appointed by the PC in Technical evaluation of the proposals.
- vii. The tender will be single stage two envelopes.
- viii. 2% earnest money in the form of Pay order in the name of PDMA Sindh will be accompanied with Financial Proposal.
- ix. The successful bidder will have to deposit performance guarantee to the tune of 8% of the quoted value at the time of award of contract.
- x. Tender will be opened at PDMA Head office Karachi i.e. Bunglow No. 40, Street No. 24, Khayaban-e-Mujahid, DHA, Phase-V, Karachi.
- xi. Bid evaluation criteria available on SPPRA website was examined and decided for adherence while evaluating the proposals.
- xii. Weightage will be given to past experience and financial data provided by the bidder.
- xiii. A Technical Sub Committee will be constituted for Technical evaluation / assessment of the items viz, Tent, Plastic Mats, Mosquito Nets, Blankets, Solar LED Lights, Water Tank, De-watering Pump, Jerry Cans, Rescue Boats, Life Jackets, Generator Sets. The service of any concerned agency / co-opted member may be hired for this purpose. The services of the agency / co-opted member(s) so included will be utilized against financial consideration from the proceeds received as tender fees on rational basis.
- xiv. The PC will start evaluating technical proposals following the next day of opening of tender.








During the course of meeting amendments so pointed out in the specification of item(s) (S.No. 9, 10, 12 & 13) so reviewed by PC are as under:

TECHNICAL EVALUATION REPORT IN RESPECT OF RELIEF ITEMS / EQUIPMENTS

In pursuance of the decision taken in the meeting of the Procurement Committee dated: 06.05.2015, the technical evaluation of the technical proposals was conducted on 13.05.2015 at 04:00pm.

Reference:

- A. PDMA(Sindh) letter No.PDMA(S)/7(18) 2015 dated 7 May 2015.

M/s BET

- a. Offered boats were flat bottom fiber glass (14' and 23') light in weight.
- b. Can accommodate 8 to 10 men and 20 to 25 men respectively.
- c. Can operate in shallow water.
- d. Offering YAMAHA engines of 30HP & 48 HP respectively which are commonly used in Pakistan. Spares support is available locally.
- e. Firm has past experience of manufacturing and providing similar type of boats for relief operations.
- f. Firm has a complete set up in Karachi for manufacturing and maintaining such kind of boats including mobile repair team with all facilities to cater for the defect on site.
- g. Offered boat are light in weight, therefore easy to lift and maintain.

OBSERVATIONS

- a. Already fitted engine's seating plate (aluminum) thickness was found less. Same is required to be increased.
- b. Rubber line around the boat need to be strengthened with stainless steel screws or as appropriate.
- c. Technical team of PDMA(Sindh) is required to undertake training to maintain boats and engines during and after operations or been undertaking by the firm to do so for 10-12 years be obtained.

M/s MODERN MOTORS

- a. Fiber glass boat 15' was presented and 23' was not presented to the team. Therefore, same was not evaluated.
- b. 15' boat was curved down ward to the bottom.

c. Firm has offered Mercury OBM engines 30 and 50 HP with these boats not very casually used. Since these are less in number therefore same needs more lead time for spares to arrive in Pakistan.

OBSERVATIONS


- a. Already fitted engine's seating plate (aluminum) thickness was found less. Same is required to be increased.
- b. Rubber line around the boat need to be strengthened with stainless steel screws or as appropriate.
- c. Technical team of PDMA(Sindh) is required to undertake training to maintain boats and engines during and after operations or been undertaking by the firm to do so for 10-12 years be obtained.
- d. 15' boat is not considered suitable for shallow water operations.
- e. Firm's setup for boat manufacturing is in Lahore not in Karachi.
- f. 23' boat was not presented for evaluation.
- g. Firm may be asked for spare supportability and defect rectification of Mercury Engines.

DECISION

- a. **M/s BET** - Technically Acceptable subject to clarification of observations.
- b. **M/S MODERN MOTORS** - Technically Rejected due to following reasons:
 - a. 23' boat was not presented for evaluation.
 - b. 15' boat not suitable for shallow water operations.


