1. The Regional Directorate of Food Sukkur /Procuring Agency invited bids for opening the same on 29.04.2014 from the interested parties for transportation of wheat/bardana & Miscellaneous work etc, for within District & other Districts (within Region) for the period ending upto 28.02.2015 vide this office Tender Notice No.AC-17(Tend)/2014-15/897 dated 09.4.2014 which were published in various news papers viz: daily Pak Sindh, The News, Sobh, Sindh Express dated 13.04.2014 & ,daily Nijat & Express dated 14.04.2014. The parties participated in the Tendering process on 29.04.2014.

The tenders were opened on 29.04.2014 in presence of the following members of the procurement committee constituted by Food Department Government of Sindh under the SPPRA Rules.

- 2. 47 (Forty seven) Blank tender forms were issued to parties upto 28.04.2014 alongwith details of work and the amount of security deposits shown in the bid documents / statement. Out of which 29(twenty nine) envelopes were received from parties on 29.04.2014 within the fixed time alongwith 09 (Nine) Technical Proposals from them, hence 13 parties / Transport Contractors already qualified in previous tender process dated 12.03.2014.
- 3. The Technical proposals were opened in presence of the above procurement committee members and the concerned parties or their representatives which procurement committee have been examined and found that out of 09(Nine) Technical proposals, 06(Six) found satisfactory / considerable and 03 proposals of M/s Muhammad Younis of Ghotki District, Nazir Ahmed Sahito & Abdul Ghafoor Rajper of N.S.Feroze District disqualified by Members of Procurement Committee due to non fulfillment of required conditions of Tender Notice.
- 4. On opening the 29 (twenty nine) Financial Proposals (envelopes), (29) filled tender forms were found supported with security deposits.
- 5. After opening the Financial Proposals, the members of the committee have examined each & every proposals and found overwriting and cutting and also some observations which are as under:-

i. Mr.Muhammad Anwar Malik Transport offered following rates to the routes shown against each only in figures & not offered in words shown at Sr.No. 01 & 03 in comparative statement of District Ghotki which is violation of condition of para 05 of the tender notice issued under No.AC-17(Tend)/2014-15/897 dated 09.4.2014, therefore the Members of Committee decided that such offered rates may not be considered.

ii. Mr.Shahzad Ahmed Malik Transport Contractor made heavy cutting / over writing in the rate offered in figures as well as in words at Qadirpur to Ghotki route shown at Sr.No. 13 in comparative statement of District Ghotki which is violation of condition of para 05 of tender notice issued vide No.AC-17(Tend)/2014-15/897 dated 09.4.2014.The Members of Procurement Committee decided that due to violated condition of Tender Notice by 1st lowest party so his offered rate may not be considered and 2nd lowest rate offered by Mr.Khalid Hussain Samo Transport Contractor may be considered.

- iii. M/s.Muhammad Anwar Malik & Shahzad Ahmed Malik Transport Contractors made heavy cutting / over writing in the rate offered in figures as well as in words for transportation of wheat from District Ghotki to Sukkur shown at Sr. No.27 in comparative statement of District Ghotki which is clear cut violation of condition of para No.5 of Tender notice bearing No.AC-17(Tend)/2014-15/897 dated 09.4.2014, therefore their offered rates may not be considered.
- iv. Mr.Muhammad Saleem Shaikh Transport Contractor made completely cutting in the offered rates at routes/centres namely Kandhra to Sukkur, Salehpat to Sukkur, Dhulwaro to Sukkur, Janujee to Sukkur and Tarai to Sukkur, therefore the same may not be considered.
- v. M/s Muhammad Saleem and Aftab Hussain Pirzada have offered same rate i.e. Rs.35/- from W.P.Centre Ripri to Gambat, shown at Sr.No. 08 in comparative statement of District Khairpur. The Members of Procurement Committee decided that rate offered by Mr.Muhammad Saleem Shaikh may be considered due to sound party.
- vi. Mr.Aftab Hussain Pirzado Transport Contractor made heavy cutting in offered rate for transportation of wheat from Hinydari to Setharja shown at Sr.No. 28 in comparative statement of District Khairpur which is violation of condition of para 05 of Tender notice issued vide No.AC-17(Tend)/2014-15/897 dated 09.4.2014. The Members of Procurement Committee decided that due to violated condition of Tender Notice by 1st lowest party therefore his offered rate may not be considered and 2nd lowest rate offered by Mr.Muhammad Saleem Shaikh Transport Contractor may be considered.
- vii. M/s.Shoukat Ali Shah & Arbab Ali Shah Transport Contractors of N.S.Feroze made completely cutting at W.P.Centre Bhorti to Kandiaro which is violation of condition of para No.05 of Tender notice issued vide No.AC-17(Tend)/2014-15/897 dated 09.4.2014, therefore their rates offered may not be considered.
- viii. Mr.Shoukat Ali Shah Transport Contractor N.S.Feroze made some cutting at W.P.Centre Bhorti to Darbello shown at Sr.No. 21 in comparative statement of District N.S.Feroze. However cutting is ignored.
- 6. The necessary comparative statement was prepared then & there in the presence of all the above Members of Procurement Committee and parties. As per procedure, the rates were read over loudly and clearly before parties.
- 7. However, the party-wise & route-wise details of the lowest bidders are shown as under.
