- The Consultants have therefore recommended as under:-
 - The bidding pattern shows that the bidders have not reduced the bid prices significantly, as was anticipated when the bids were run in second round of bidding which shows that the same pattern of high bid prices as in the first round of bidding persists in the second round also.
 - In view of the above, all bids may be rejected on ground of substantially high prices in comparison of estimated cost (Engineer's Estimates). Furthermore, a comprehensive future bidding strategy may be developed in consultation with the SCA in order to get the viable / competitive prices.
- The Bid Evaluation Reports alongwith Consultants recommendations were placed before the Procurement Committee in the meeting on 27.11.2013 in the Committee Room of Sindh Coal Authority chaired by Additional Secretary, Coal Energy Department, Gud of Sindh.
- The Committee reviewed the Bid Evaluation Report and by discussing the same in detail found Evaluation Reports in order and satisfactory as per SPPRA Rules and endorsed the recommendations of the Consultants for rejection of all the bids as the rates quoted by the lowest bidders are still higher than the Engineer's Estimates and already awarded contracts even considering the market inflation / escalation of prices as compared to the rates previously received and approved.
- Looking to the recommendations of Procurement Committee and keeping in consideration the high rates, which are still much beyond the Engineer's Estimates viz. 31.26% above for CP-II, 33.56% above for CP-V & 35.63% above for CP-VI quoted by the lowest bidders M/s. Umer Jan & Co., M/s. Fazal & Brothers and M/s. Mumtaz & Co. respectively, it is requested that the bidding process may be annulled and approval for rejection of lowest quoted rates may be accorded in the best interest of public work.
