
1. For IVC five bids were submitted. After careful evaluation, the lowest bid from M/S Techno Medical System was selected & recommended for placement of order.
2. For Bio-safety cabinet seven bids were submitted. Six bids from Scien Tec, Unitech Scientific, Zelon scientific, Ins-tech, SKTC and madina engineering services were rejected due to the fact that required specifications were not present in the bio-safety cabinet. Therefore these six bids were considered invalid.

The committee has recommended re-tendering the bio-safety cabinet since only one valid bid was left for the sake of healthy competition.
