

Minutes of the meeting of Procurement Committee regarding opening of Bids held 03-04-2018 Under the Chairmanship of Mr. Shaharyar Akhter Kazi, Project Manager of the Scheme Titled “Improvement of Major Fishermen’s Settlements & Rehabilitation of Flood Affected Areas in Coastal Areas of Thatta, Sujawal & Badin Districts” (IMFS), Sindh Coastal Development Authority Karachi.

The chair welcomed the participants and asked Mr. Zameer Hussain Ujjan Deputy Director (Agri) SCDA / Secretary Procurement Committee IMFS to start the proceedings of Meeting. Mr. Ujjan thanked the chair and apprised the forum that the NIT of 19 nos. schemes of category-B “Roads & Water Supply” was invited from the prequalified contractors via courier service and through SPPRA Website at Serial No. 35184 dated 09-11-2017. The bid was opened on 22-12-2017 as scheduled, the Procurement Committee’s recommendations were sent to SPPRA to be publicly announced but the same was rejected by the SPPRA and instruct this authority vide SPPRA letter No. AD(Assess)SPPRA/35184/2018 dated: 08-02-2018 to re-invite the fresh NIT for open competitive bidding. Fresh NIT was published vide leading national newspapers and SPPRA website at Sr. # 36837 dated 16-02-2018. Bid opening scheduled on 06-03-2018 was cancelled due to incomplete quorum. Fresh NIT was again published vide leading national newspapers and SPPRA website at Sr. # 37249 dated 13-03-2018. The opening of bids has been scheduled for today 03-04-2018 at 2:30 PM.

The Chair apprised the forum that if the firm / contractor is not sound in eligibility criteria, should be declared “technically disqualified” even his bid to be the lowest, the committee will not recommend. The Chair further apprised that the bids which are more than below 30% threshold will not be considered for award of contract as per SPPRA Notification No. DD(A&F)/SPPRA/17-18/22 dated: 05-07-2017. The Chair decided to open each scheme’s sealed envelopes separately as per the NIT Serial numbers. The sealed envelopes were opened scheme wise one by one by the Procurement Committee in presence of Bidders / Firms Representatives. The quoted bid prices were read out and noted in bid opening sheet as well as amount of call deposit / bid security was checked as per tender / bidding document and signed by the available representatives of firms. Some of the bidders / firm’s representatives who signed the attendance sheet either did not submit their bids or they were absent at time of their bids were opened. Following position of bids has been clearly visible.

**1. Construction of Road from Nizamani Farm Road to Ladiun Kothi Road

Out of 4 bidding documents sold for the scheme and all the 4 bidders have submitted their bids. The bids were checked thoroughly with the help of Bid Opening Checklist

and found M/s. Allah Warayo Samoo is technically disqualified as he has not submitted documents as per the eligibility criteria and M/s Rajgan Enterprises did not provided bid security hence their bids were rejected. The bids were arithmetically calculated, no discount offered by any firm / contractor.

Haji Habibullah Khan are technically disqualified as they have not submitted documents as per the eligibility criteria and M/s. Akhter Shah Mandokhail submit empty bid and was also absent at the time of bid opening. The bids were arithmetically calculated, no discount offered by any firm / contractor.

The sealed envelope submitted by M/s M.M Karim Brothers did not contain documents as per the eligibility criteria and Financial Proposal, no pay order for Bid Security was provided as well as no representative was present at the time of bid opening. 


