Following three Chemists/Pharmacies were participated in the tender.

- i) M/s S.S. Medicos have not submitted Bid Security, month wise GST statements and Good performance Certificate. Their tender rejected. They offered 7.00% discount on retail price.
- ii) 2nd participant is M/s Naveed Medicos is situated at Nazimabad, which is 16-18 K.m from JPMC. They can not meet the emergencies. They have also not submitted month wise GST statements and Good Performance Certificate. Their tender has rejected. They offered 8.50% discount on retail prices.
- iii) 3rd participant is M/s Taj Medicos, Reagent Plazam Karachi. They submitted all required documents s participated in the tender. Only M/s Taj Medicos qualified Bidder. They offered 8.25% discount on retail price.

The last year (2011-12) discount was 6.00% on retail price.

Purchase Committee has accepted the offer of M/s Taj Medicos for the supply of Drugs/Medicine, Surgical/Disposable Items on discount of 8.25% on daily basis for the year 2012-13.
