Muzammil Traders Company offered "Hibachi" Sewing Machine @ 4450 which was found not according to tender specification & sub standard machine so committee rejected the proposal of the bidder. The second lowest M/s. ANI Traders, Salika Sewing Machine with all accessories Electric Motor & Cover @ 6996 per Sewing Machine & total bid cost of Rs.9374640/= Salika Sewing Machine being a popular famous & good material / condition according to the specification considered according to the required tender specification so committee approved the offer of the same.
