






A notice for inviting tender from the interested bidders was sent under Rule 17 of SPP Rules, 2010 to the Sindh Public Procurement Regulatory Authority for hoisting on the Authority's website and the date of opening tender was 11.05.2015, which was subsequently extended to 12th May, 2015.

03. Unisys Corporation Pakistan.

Out of the above Mr. Choudhry Anjum Shakeel representing Quick Marketing Services attended the bid opening process. Remaining two bidders namely M/s. Al-Rashid Micro Computer (Pvt) Ltd and Unisys Corporation Pakistan were not in attendance and called absent.
