







- c. The bid package must consist of two sealed envelopes:
 - First envelop marked: "UCG/Tender/Elect-187/2014 TECHNICAL OFFER" should contain the technical documentation and technical specifications with reference, statements, literature, drawings, as appropriate. An un-priced financial offer shall be made part of the technical offer.

- Second envelop marked: "UCG/Elect-187/2014 FINANCIAL OFFER" should contain a financial offer and 2% of total cost of the bid as earnest money in shape of Bank Draft/Pay Order in favor of Accounts Officer UCG Thar.
