4. The bid contain over-writing and cutting duly signed.


The Procurement Committee-I has observed the following discrepancies.

- iii. Rate of Item No.7 are based on %0 Cft but contractor M/s.King Asif Rehman & Brothers has quoted the rate %Cft.
- iv. Both contractors have not provide the documents as per eligibility criteria as per Rule-46(i).
5. The committee have examine all the bids as per the qualification / eligibility criteria provided in the bidding document and verify the documents and bid security submitted by the bidders and recommends to re-invite the tender through press as well as SPPRA Web site.
