- 3) The meeting was held on 25th July, 2014 at 10:00 AM in the Committee Room of Administration Block for technical evaluation/scrutiny of documents of technical bids, all are found according to tender requirement. After detail deliberation the tender committee for out sourcing services recommended that technical bids of above eight (08) firms may be considered for opening of financial bids.

- 4) The commercial/financial bids of these firms were opened in the presence of their representatives, but re-presentative of M/s: Agha Security Services (Pvt) Ltd., was not present in said process.
