



TCS (Pvt) Ltd., a Private Limited company incorporated under the Companies Ordinance, 1984 having its registered office at (TCS House, Saqib Hamdani Building, Iqbal Avenue, Jinnah International Airport, Karachi 75202, Pakistan), (hereinafter referred to as "(TCS)" which expression shall where the context so admits include its administrator, successor in office and permitted assignees) of the OTHER PART;

AND

SINDH BANK LIMITED, a banking company incorporated under the laws of Pakistan and having its Head office at 3rd Floor, Federation House, Abdullah Shah Ghazi Road, Clifton, Karachi-75600, Pakistan. (hereinafter referred to as "BANK", which expression shall be deemed to mean and include its successors-in-interest and assigns) of the Second Part.

WHEREAS:

SINDH BANK is a banking company involved in the business of providing banking services including Islamic banking to its customers;

b. The BANK is desirous to acquire the services of TCS for the provision of domestic and international Courier Service and TCS agrees to provide the said services to the bank in accordance with the description of goods/articles, standard and instructions given by the Bank on the terms and conditions, as mentioned in the tender document issued by the Bank and as per the rate quoted in the financial proposal of the tender document for the said services.

The BANK desires transportation of mail envelops packets, packages and goods inbetween Karachi, Lahore, Islamabad, Quetta, Peshawar and other places within the

network of the TCS in Pakistan hereinafter referred to as the destination and the TCS agrees to provide these services of transportation on the following terms and conditions:

General Terms & Conditions:

- 1. This agreement shall become effective and binding upon the parties from the date of signing hereof and shall remain valid for a period of one year from the date of signing of signing unless terminated earlier or extended by either party on the same terms of thirty (30) days prior to the expiry date.
- 2. The TCS shall not be liable for any delays or non-performance resulting from circumstances or causes beyond its reasonable control, including without limitation, like acts of God, flight dislocation, plane crash, war, hostilities, revolutions, strikes, epidemics, unavoidable accident, fire, flood, earthquake, explosions or any other cause similar in nature or due to any law & order situation or requirement of any governmental agency or authority'.
- 3. Either side on 30 days notice can terminate the Agreement for reasons that will be recorded in writing and/or without assigning any reason.
- **4.** The terms of the Agreement shall be governed by the laws of the Government of the Islamic Republic of Pakistan in vogue and as may be amended from time to time.
- 5. In case of dispute, the matter shall be sorted out amicably, failing which through arbitration and if still remained disputed or unsolved will be resolved in accordance with Clause 19 hereunder.
- 6. This Agreement or any of its terms may be varied, amended, waved or discharged only by mutual consent of the parties in writing.
- 7. This agreement shall a period of 1-Year commencing from 29th October, 2014 till 28th October, 2015.
- 8. The parties to this Agreement, if desirous of renewing the terms of agreement, may do so on the same terms and conditions or with such modification as may be mutually agreed upon between the parties.
- 9. The BANK shall provide, envelops, packets, packages and goods for transportation to destinations from time to time for delivery in prescribed given period in good order and condition marking suitable to the mode of transportation.

- 10. The BANK shall provide full name, address, telephone number of Destination prominently on each envelop / packet / package. / Goods etc.
- 11. The TCS shall transport envelops / packets / packages / goods to destination and deliver the goods overnight (exclusive of holidays) in a timely manner in good order and condition.
- 12. Envelops / packages / packets / goods shall be delivered by the TCS to the destination on within the prescribed time frame, after receipt of the same by the TCS from the BANK provided the envelops / packages / packets / goods are to be delivered to Karachi, Lahore or Islamabad and/or any other destination all over the country and abroad as per their rates quoted for particular service.

16. Notices

All notices, requests, instructions, claims, demands, consents and other communications required or permitted to be given hereunder shall be in writing and shall be deemed to have been duly given: (a) on the date delivered by hand or by courier service such as Federal Express, or by other messenger if duly acknowledged, such delivery is refused, upon presentment); (b) upon receipt by facsimile transmission, or (c) upon delivery by registered or certified mail (return receipt requested), first-class postage prepaid, to the Parties at the above addresses.

17. Governing Law/Jurisdiction

This Agreement shall be governed by laws of Pakistan. The Parties agree on the exclusive jurisdiction of courts at Karachi for taking up any or all issues arising out of the execution of this Agreement.

18. Termination.

This Agreement may be terminated:

i. By serving a 60 (sixty) day notice by the Bank without assigning any reason;

ii. By serving a 60 (sixty) day notice by TCS without assigning any reason;

iii. By serving a written notice in case the other Party commits a material breach of this Agreement including default in payment under this Agreement, of such invoices which are not disputed. Upon receipt of notice, the defaulting Party shall have a period of 15 days to rectify such breach (if rectifiable), failure whereof shall lead to termination of this Agreement upon expiry of the notice period.

19. Dispute Settlement

It is agreed by and between the Parties hereto that they shall use their best endeavours to resolve any disputes, differences or questions which may arise between the Parties hereto that touch upon the subject matter of this Agreement, through mutual consultation.

However, in case of any unresolved dispute, controversy or claim arising out of, relating to, or in connection with this Agreement shall be referred to and finally resolved by arbitration in Pakistan at Karachi, through a sole arbitrator, appointed with mutual consent of Parties, in accordance with the provisions of Arbitration Act 1940.

20. Amendment

No amendment, addenda or other modification of this Agreement shall bind either Party hereto unless made in writing, approved and signed by representatives of both Parties with the actual authority to agree to same.

21. Assignments / Successors.

Both Parties are restricted to assign any of their rights and/or obligations under this Agreement without the prior written consent of other and any purported assignment without such consent will be void. Subject to the foregoing, this Agreement and all of the provisions hereof shall apply to, be binding upon, and inure to the sole and exclusive benefit of the Parties hereto and their successors and permitted assigns.

22. Restrictions

TCS shall not be responsible for any shipment carrying Currency, Jewelry, Bullion, Antiques, Contraband, Liquor, Stamps, Precious Stones, Work of Art, Fire Arms, Plants, Drugs, Explosives, Animals, Perishable, Negotiable Instrument, in Bearer Form, Lewd, Obscene or Pornographic Materials, Industrial Carbons Diamonds and any other item/article which is restricted and/or prohibited by any law, regulation or statute of any Provincial or Government of Pakistan.
