

The meeting started as per schedule, Director General Livestock Sindh / Chairman Procurement Committee welcomed the participants of the meeting and opened the discussion on agenda item for:-

Procurement of Veterinary Medicines, Drugs and Animal Feed for office of the Deputy Director Livestock Development Project Hyderabad, for the use in drought affected area of Kohistan Region, during the year 2014-2015.

Deputy Director Livestock Development Project Hyderabad, informed the forum that tenders were called through Newspapers for purchase of above items against the allocation of Rs:8.000 million, provided under Non-Development Budget. Tenders appeared in Daily "SINDH EXPRESS" dated 19.03.2015, Daily "EXPRESS" Dated 20.03.2015 & Daily "THE EXPRESS TRIBUNE" Dated 19.03.2015 and were purchased by 35 firms out of which 33 firms responded and provided the relevant / required documents like CDR, Income Tax, Professional Tax, GST Certificates, authority letter, agreement and registration of item with Ministry of Health Government of Pakistan.

The tenders were opened by the Procurement Committee on 06.04.2015 and scrutinized in its 2<sup>nd</sup> meeting held on 23.04.2015. Accordingly comparative statement prepared and placed before the Procurement Committee.

In the light of recommendations and justification provided to the Committee, the Procurement Committee decided that:

- Items for which three or more than three firms participated in the tendering; the Procurement Committee approved the procurement from 1st lowest firm after observing quality plus standard condition and durability of the items.
- Items for which two or only one firm(s) quoted the rates as per SPPRA rule 48 acceptance of bid, the Procurement Committee approved the rates after observing quality and durability of the items; as under:



- The mixed animal feed with maximum nutrient values should be purchased through direct contacting from local market / reputed firms on competitive rates by obtaining quotations on need basis
- The medicine items of homeo & herbal in nature quoted in the tenders of antibiotic & antiparastic will not be purchased.
- > The firms shall provide minimum one year shelf life of medicines.





- It should be ensured that items to be purchased shall be of specific quality from reputed firms.
- All the firms will liable to pay sales tax (payable under rules) from the approved cost.
- All the firms will have to pay income tax, Sindh stamp duty and all other usual taxes payable under rules.
- The payment shall be made to the firms against the supply of the items subject to the inspection report ensuring that items are according to the specification.
- All the firms will be responsible to deliver the goods at their own expenses within thirty (30) days after issuance of the supply order, failing which their supply orders will be treated as cancelled and same will be issued to 2<sup>nd</sup> lowest bidder (subject to qualifying technical specifications).
