SPECIAL CONDITIONS OF THE CONTRACT

The following Special Conditions of the Contract are deemed to be additional Clauses or shall supplement the "General Conditions of Contract". Whenever there is a conflict, the Provisions herein shall prevail over those in the "General Conditions of the Contract".

- DEPARTMENT AND ENGINEER (Clause-1 of Section-II)
 - Pursuant to Para (g) and (h) of Clause 1.1 of Section-II, following are the Duties & Powers of the Department and the Engineer.
- 1.1 Department's Duties: The Department shall carry out such duties in issuing decisions, certificates and orders as are specified in the Contract.
- 1.2 Department's power to delegate to the Engineer: The Department may from time to time in writing delegate to the Engineer any of the power, discretions, functions and/or authorities vested in her and may at any time revoke any such delegation.
- 1.3 Any written decision, instruction or approval given by the Engineer to the Supplier in accordance with the terms of such delegation (but not otherwise) shall bind the Supplier and the Purchaser as though it had been given by the Department provided always that:
 - (a) any failure of the Engineer to disapprove any Goods, supply or materials or workmanship shall not prejudice the power of the Department thereafter to disapprove such Goods, supply of materials or workmanship as not acceptable and to order the rectification thereof in accordance with these conditions;
 - (b) If the Supplier shall be dissatisfied by reasons of any decision of the Engineer, they shall be entitled to refer the matter to the Department who will either confirm, reverse or vary such decision.
- Duties and Power of the Engineer: The Engineer shall be responsible to the Department and his duties are to watch, supervise and certify delivery of the Goods to the consignee and to examine and supervise testing of any Goods or materials to be used or workmanship employed in connection with the Goods. Further the Engineer will process the commercial invoice of each partial shipment submitted by the Supplier for payment after fulfilling codal formalities. The Engineer shall have no authority to relieve the Supplier of any of his duties or obligations under the Contract nor to make any Variation in order nor accept as expressly provided in the Contract, to order any delivery involving delay in completion or any extra payment to the Supplier by the Department.
- DESIGN AND DRAWING (Clause 3 of Section-II)
- 2.1 The Supplier shall, within the time stated in Clause 3.3 of Section-II, submit plan showing overall dimensions, construction details, installation procedures and data necessary to demonstrate that all parts of the Goods being supplied conform to the requirements of the Specifications.
