





- a. Blank tender forms can be collected from the office of Procurement Officer, UCG Project Thar, upto 23 June 2014 at 12:00 Noon, during office hours after depositing the tender fee amounting to Rs.500/- (Non Refundable) in the shape of pay order in favor of Accounts Officer, UCG Thar Project, Islamkot.
- b. The tender documents will be received back up to 24 June 2014 at 1100 Hrs and will be opened on the same day at 1200 Hrs in the presence of Procurement Committee and the bidders or their authorized representatives who wish to be present.
- c. Bid Security amounting to 2% of Bid Price should be submitted along with the Bid in shape of Pay Order in favor of Accounts Officer, UCG Thar Project, issued by any scheduled Bank of Pakistan.
- d. The bid security will be forfeited to the Government, if the bidder withdraws his bid after opening and before the expiry of the bid validity period or fails to sign the contract if the bid is accepted.
- e. Bids validity should be for one year on following terms and conditions;
 - i. Rates should be quoted as per Government Control rates (Govt. control rate list should be attached).
 - ii. Suppliers profit should be mentioned separately with all other taxes/ charges.
 - iii. Rates should be quoted Ex-Godown Mithi.

- iv. Any decrease / increase in Government Control Rates, quotation can be revised and will be adjusted accordingly.
 - v. Necessary certificates, i.e. GST / NTN or authorized dealership certificates should be attached with bid.
 - vi. Successful party has to sign the contract with the UCG for the supply of one year.
 - vii. Payment will be made on monthly basis after receipt of original bill.
 - viii. In case of termination of contract three months' notice will be given by either party.
- f. Amount of the tender is below Rs.01 Million.
 - g. Conditional tender and tender without bid security shall not be considered.
 - h. Supply order will be issued periodically as per requirement of UCG project under the limit of total required quantity per year.
 - i. Delivery time will be 10 days starting after the issuance of supply order.
 - j. Receipt of bid/ tender after due time and date will not be accepted.
 - k. The procuring agency may reject all or any bid at any time prior to the acceptance of a bid or proposal, subject to the relevant provision of SPP Rules 2010.
 - l. Tender envelope should bear the tender No.UGC/Tender/Admin-194/14 and Tender for LPG Gas.
