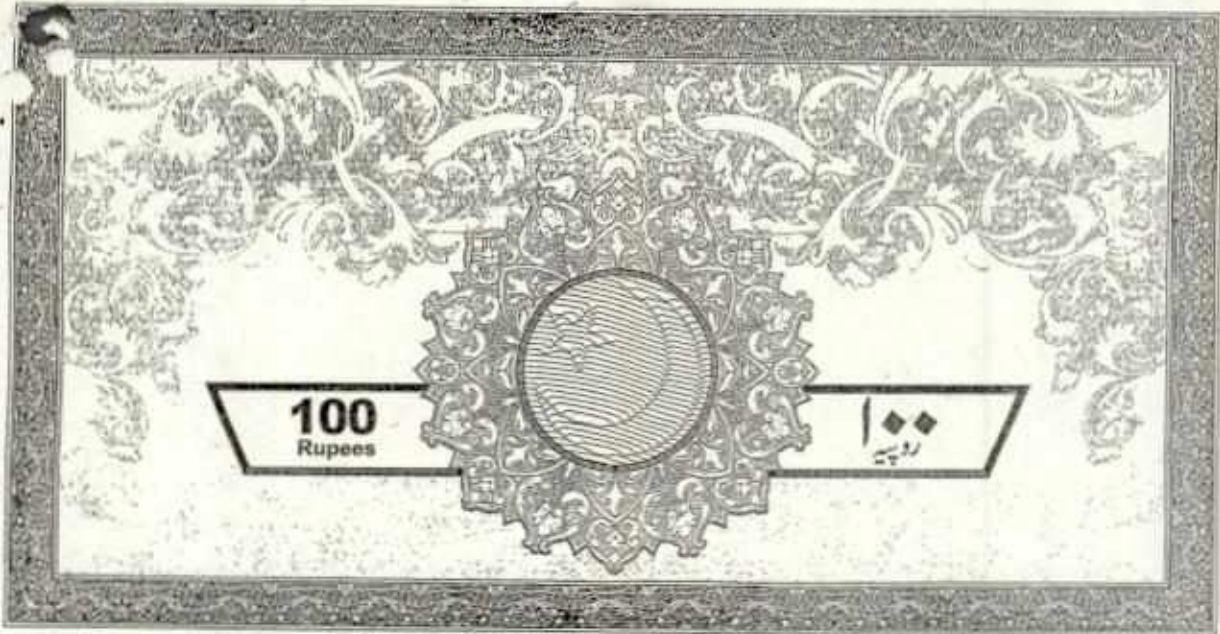

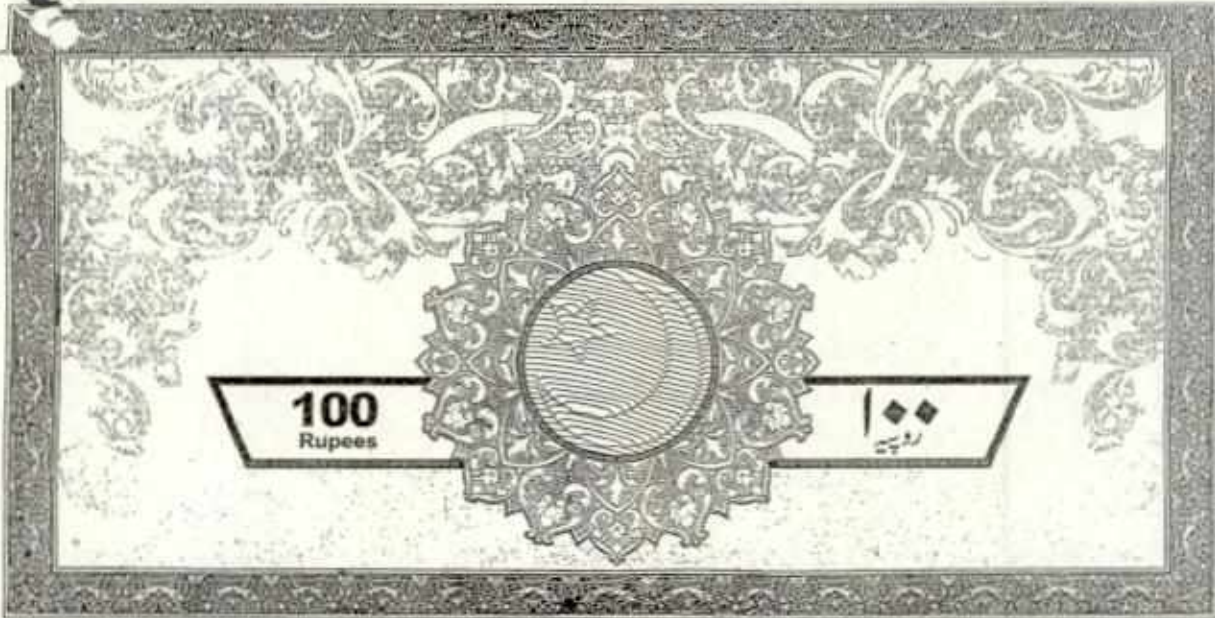
AGREEMENT
