Call to withdraw RD on import of non-luxury items

KARACHI: The local industry has earnestly demanded of the government to withdraw regulatory duty on import of those industrial inputs that do not fall under the category of luxury items. In a statement, the President Lasbela Chamber of Commerce and Industry (LCCI), Yakoob H Karim said that the Federal Board of Revenue (FBR) has taken the decision blindly and without examining the HS Codes

to impose regulatory duty on import of various items that fall under the category of luxury items. He pointed out that some iron and steel products that either not manufactured in Pakistan or come under the luxury items. He further elaborated that flat-rolled products of iron (HS Code 7210) are yet to be produced in Pakistan but are necessary in various sectors of industry as flat-rolled iron used to manufacture crown and

caps of bottles and massively 15 used in the food, beverages, packaging and other industries and due to slapping of 5 per cent R.D on flat-rolled products would increase the industrial cost to about 15 to 20 per cent. "It's not a luxury item and R.D can not be imposed on import on such items that neither produced locally or used as essential industrial raw-material", Yakoob explained.—Agency
