

## COMMITTEE REPORT

**SUBJECT: PROCUREMENT BY SINDH POLICE – FABRICATION OF TOYOTA HILUX 4x2 SINGLE CABIN WITH CANOPY PROTECTION LEVEL B4+**

M/s Vision Security, lodged a complaint to the IGP on the subject. The IGP Sindh referred the complaint to "The Redressal of Grievance & Settlement of Disputes Committee" formed vide CPO No. G-I /1061 Dated 6-8-2014, in accordance with rule 31 of Sindh Public Procurement Rules, 2010.

As a result the committee called the complainant Mr. Naveed of Vision Security on 21-8-2014. The complainant was heard in person.

According to "Sindh Public Procurement Rules 2010 (Amended 2013)" under section 31(1)

"The procuring agency shall constitute a committee for complaint Redressal comprising odd number of persons, with appropriate powers and authorizations, to address the complaints of **bidders** that may occur during the procurement proceedings.

The same rules further delineate the scope, role and functions of the committee in rule 31(3):

"Any **bidder** being aggrieved by any act or decision of the procuring agency after the issuance of notice inviting tender may lodge a written complaint".

Similarly rule 31(4) states :

"The complaint redressal committee upon receiving a complaint from an **aggrieved bidder** may, if satisfied:

- (a) Prohibit the procurement committee from acting or deciding in a manner inconsistent with these rules and regulations;
- (b) Annul in whole or in part, any unauthorized act or decision of the procurement committee;

From the above mentioned rules it is crystal clear that the grievances of redressal committee is formed to redress the grivences /complaint of **bidders only**.

During the course of hearing of the complaint, it transpired that M/s Vision Security has not participated in the bidding process.

**DECESION OF THE COMMITTEE:**

From the above facts the committee reached at conclusion that the complaint does not fall under the preview of redressal of grievances & Settlement of Disputes Committee. Hence the complaint is filed.




