After preliminary analysis of bid documents, samples of items of lowest bidder i.e Salafa & Alizha Constructor Company was called for evaluation and justifying the 28% low cost. However, after detailed scrutiny of the bid documents of M/S Salafa & Alizha Constructor Company it transpired that company has provided bank statement of only 2010 instead of bank statement of last 03 years which is not in accordance with criteria i.e. turnover of Rs.10 Million per year for last three years nor the company has provided required affidavit. As the company does not fulfill the requirements of the tender, hence stands disqualified.

The committee also carried out thorough and detailed scrutiny of the bid documents of other companies and found the following :-



The meeting ended with vote of thanks by the chair to the members and participants.




