Hayat Computers, M/S. Global Enterprises, M/S. Owais Enterprises, M/S. Trade Targets, M/S. Computer Circle and M/S. Sashun International who were qualified in Technical Proposal after scrutiny / evaluation. **(Lists of Participant attached)**

2. The Bids were opened on scheduled time at 12:00 Noon in presence of the representatives above mentioned firms/companies (except M/S. Sashun International whose representative was not present). The price/rates quoted by the qualified Bidders were read out and encircled by the Chairman of the Procurement Committee. The Committee Members signed the Financial Proposals opened on the occasion, which do not contain any over-writing or cutting etc.

3 The Comparative Statement was prepared (***Annexure-A***). The Procurement Committee Members on the occasion suggested that in in cases where there was only a single bid, quotations from three (3) different vendors be obtained and ensured that the quoted rates are in-line with the market which was approved by the Procurement Committee.

4. Subsequently, market rates of all the single bid items were obtained from 03 vendors and wherever the single bid was the lowest it was accepted. (***Price Comparison along with Three (03) quotations is attached with Minutes at Annexure-B***)

5. Consequently, the Procurement Committee recommended all firms/companies on the basis of Comparative Statement for further processing as per SPPRA Rules, 2010 and final approval of Competent Authority.
