

A Company incorporated and existing under the laws of Pakistan and having its head office at Suite # 2, Al-Karam Building, Mai Shahrah-e-Liaquat, Near Regal Chowk, Saddar – Karachi, Pakistan (Hereinafter called as "The Company"), which expression shall be deemed to mean and includes its successors-in-interest and permitted assigns):

AND

CIVIL HOSPITAL KARACHI

A department under Government of Sindh, having its office at Civil Hospital, Baba-e-Urdu Road, Karachi, Pakistan (Hereinafter called as "The Client"), which expression shall be deemed to mean and include its successors-in-interest and permitted assigns):

(Collectively referred to as "The Parties")
