

The executive officer shall be held personally responsible for any excess expenditure incurred / any liabilities created beyond authorization.
- 4. The expenditure on the schemes which have completed their projected period and have not been extended or have exhausted their approved cost and have not been revised/approved should not be incurred.
- 5. The expenditure shall be strictly according to the provision of the approved PC-1, the concerned officer shall be held responsible for any violation in this regard.
- No expenditure shall be incurred on schemes beyond the approved cost.
- 7. Director General, Rural Development Department, Hyderabad is requested to deduct the 1% TPM charges from the said release and kept at the disposal of Planning & Development Department if involved in said schemes under intimation to this Department.
- 8. The above said amount is placed at the disposal of Director (Technical). Rural Development Department, Government of Sindh, Hyderabad.
- 9. It may be ensured that all required codal formalities are fulfilled before utilization of the above funds & utilization reports are sent to Finance Department on monthly basis.
