Director Procurement informed the Committee that total 10 tender documents were purchased by the interested bidders. In this tender "Single Stage Two Envelope" procedure is adopted of SPPRA Rule 2010, clause 46(2).

After the showing sealed tender box to the participants and the committee, the box was opened, where only six tenders were found. First of all financial envelopes of the received six trenders have been separated and unsealed envelopes made to sealed and singed by the representatives of the bidders. Sealed enveloped marked technical proposals/ bids of all six bidders were opened one by one by Director Procurement, he was also checking the basic mandatory documents i.e. original F-6, NTN Certificate, GST Certificate, last three years tax return showing annual turn over more or equal than twenty million, copy of pay order not showing amount and bid offer without rate, and announced loudly before the Procurement Committee in the presence of representatives of all the bidders.

Total three tenders/ bids have been rejected and three bids have been accepted by the Procurement Committee in the light of mandatory/ compulsory clause 1.3 of the terms & conditions. Following is the bidder's qualification report.
