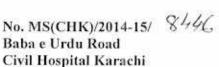

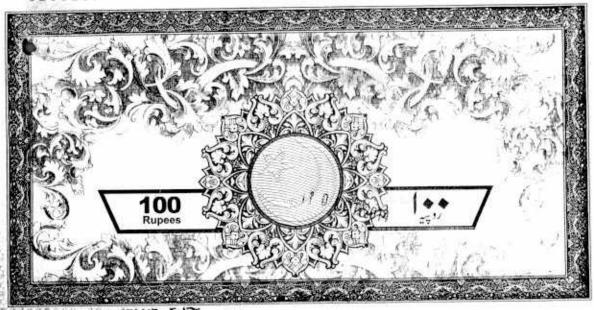

- a) Contractor shall arrange a vehicle to lifting of remains of infected / non infected garbage at the approved dumping yard of the ZMC / KMC. For this services an amount of Rs. 35,000/- per month will be charged by the Contractor.

### 4. TERM AND TERMINATION OF AGREEMENT

- a) The Agreement shall be deemed to have commenced with effect from 16<sup>th</sup> October, 2014 to 15<sup>th</sup> October, 2015 for a period of One Year and would be extendable by a further one year and may be terminated at any time by either party without assigning any reason subject to Thirty (30) days advance written notice.

- c) The Clients shall not in any case of whatsoever nature be liable for any reuse of garbage infected wastes material of its hospital including but not limited to disposal syringes, nozzles etc. In case any claim against the Clients in this respect arises by any expenses of the Client.

### 6. ASSIGNMENT

Either party shall not be entitled to transfer its right or duties under this agreement to anyone.

### 7. LAW

This agreement shall be governed by and construed in accordance with existing rules of Government of Pakistan.
