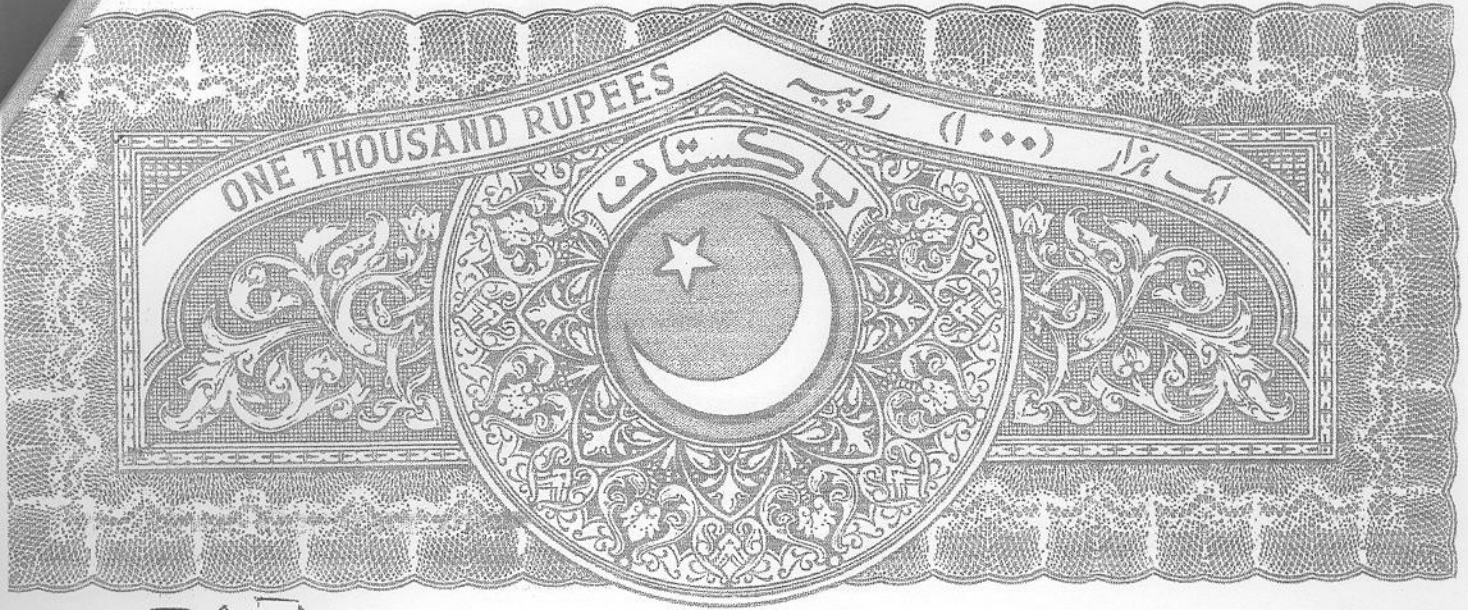

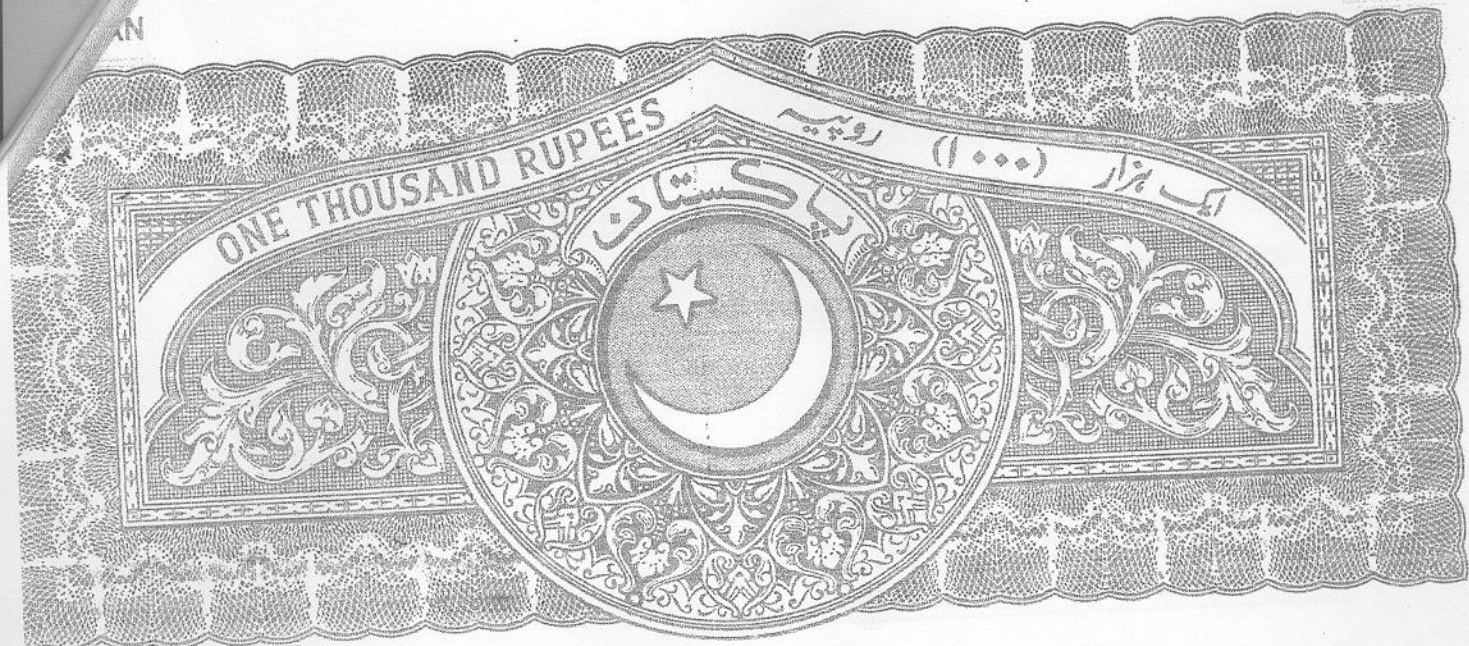
CONTRACT AGREEMENT
