It being the only qualified firm which has completed all the requirements, the offer of M/S Asad Enterprises, Hyderabad is accepted by the Procurement Committee in accordance with the SPPRA Rule 48 of 2010 which says:-

“Even when only one bid is submitted, the bidding process may be considered valid, if the bid was advertised in accordance with rules, and prices are comparable to the prices or rates of the last awarded contract or the market prices”

The same is to be sent to the SPPRA for hoisting it on SPPRA official website.




