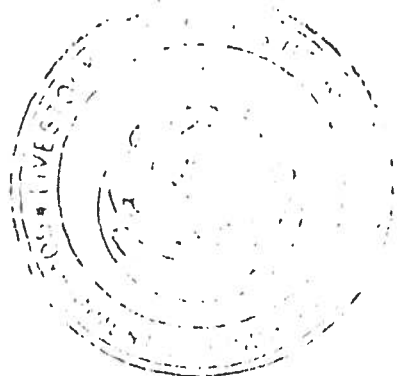


(12) firms of Karachi, Hyderabad, Badin purchased the tender documents from which all (12) firms submitted the tender documents.

Additional Director Livestock Production Thatta informed the Procurement Committee that in the light of decisions of the 1st meeting of the committee, all the documents submitted by the participating firms with the tenders were checked in detail and prepared the BQR showing the status of each participating firm, the same is placed herewith before the committee for further necessary action.

The Committee thoroughly examined the tenders and the chair emphasized and directed the Additional Director Livestock Production Thatta to strictly follow the below instructions and concerned firm who has submitted the less Bid Security / short documents should be disqualified. Accordingly Bidders Qualification Report (BQR) and comparative statement be prepared to be discussed in the next meeting of the Procurement Committee.

1. Only the rates of those items may be included in the competition for which registration of item with Ministry of Health GoP is provided by the participating firm along with authorization certificates issued by the manufacturer / importer in favor of participating firm.
2. Single offer received for any item must be compared with the market rate OR from the MRP list issued by the manufacturer / importer, any rate found over the MRP / Market rate must be rejected and recommendation made as per SPPRA rule.
3. Items for which no any firm offered the rate, if Procuring Agency feels the necessity of items and are essential to be purchased may be recommend to the Procurement Committee for purchase on need basis from the reputable firms on competitive rates by obtaining quotations.
