## MINUTES OF THE PURCHASE COMMITTEE MEETING

HELD ON .26th MAY.2015 (Financial Proposals)

The meeting of Purchase Committee was held to consider and decide Tender opened on 31.03.2015, regarding Fumigation service "ON PERFORMANCE BASIS", as per working paper circulated vide notice of meeting dated 25.05.2015.

- Opening the discussions, the Chairman welcomed the participants and apprised them that the Department, will procure 0.900 Million Tons wheat out of current Crop-2015 against the target fixed by Government. Out of which 0.855 million tons procured upto 25.5.2015 by the Department and holding carry over wheat stocks of more than 0.700 Million tons as such increasing total availability to 1.600 million tons valuing to Rs 52.000 billion approximately. Currently due to bumper wheat crop in the country and overall carry over wheat stocks coupled with the low open market rates. As such until the market forces allow release of wheat, it is expedient to take all the precautionary measures for the safety & security of the Government wheat stocks till their clearance from the godowns. The committee was apprised that the department does not have expertise for furnigating the wheat stocks to get fumigating work through technical personal for giving guarantee for security of inside & outside of stocks.
- The Committee was informed that tender for fumigation of wheat stocks by providing all the required services as well as stores by firm itself "ON PERFORMANCE / RESULT ORIENTED BASIS". Accordingly the tender was floated in accordance of SPPRA Rules, (Technical & Financial Proposals) the Technical Proposals, which was opened on 31.3.2015 in the presence of parties / firms. However, the

Therefore, it was decided by the purchase committee during the meeting that :-

- a, Award Contract to M/s Adeel Pesticides & Manufacturing Co. being lowest bidder at the rate of Rs.113/-per ton (Rupees One hundred thirteen only) inside godowns and Rs.121/- per ton (Rupees One hundred twenty one only) outside (open) including 16% GST, Taxes and Rs.10/- per ton "As Service Charges" by PARC, with all required materials / stores offered in the tender and shall be fumigated of wheat stocks stored of designated districts of Karachi/ Hyderabad / Mirpurkhas / Sukkur / Larkana Regions.
- b. The company shall be responsible to all the terms & conditions of the tender as well as agreement including guarantee of safety of wheat stocks for Nine months including rodent control.
- c. Monthly inspection of stocks shall be carried out jointly by a team consisting of representatives of company, Food Department & Pakistan Agriculture Research Council, and certificate of satisfaction shall be issued by PARC.
- d. Payment shall be made to the Company/Firm subject to verification through next Inspection report received from Committee as discussed in sub para (c).
- e, Company shall be responsible for warranty of Nine months that in the event of noticing unsatisfactory results, they are bound to re-fumigate at its own expenses without charging any extra cost to the department.
