

THIS AGREEMENT is made in stuplicate at Karachi on this 22nd November 2014.

BETWEEN

M/S. DEFENDER SECURITY SERVICES (PVT.) LIMITED

A Company incorporated and existing under the laws of Pakistan and having its bend office at Plot # 110 Mezzanine Floor, 10th Commercial Street, Plasse - IV, D.H.A. Karachi, Pakistan (Hereinafter called as "The Company"), which expression shall be deemed to mean and include its successors-in-interest and permitted assigns)

AND

CIVIL HOSPITAL KARACHI

A department under Government of Sindh, having its office at Civil Hospital, Baha-e-Unda Road, Karachi, Pakistan (Hereinafter called as "The Chent"), which expression shall be deemed to mean and include its successors-in-interest and permitted assigns)

(Collectively referred to as The Parties")

WHEREAS the Company being a firm formed for the purpose of operating security services within the Sindh Province having more than Eight (8) years of experience and has its security guards and personnel who are well turned in the field of security and fully turnished with all necessary equipment/weapons/ammunitions to perform the security services provides security services.



prof. M. Saeed Quraishy Medical Superintendent Civil Hospital, Karachi. WHEREAS the Client is dealrous of availing the services offered by the Company and the Company has agreed to provide its services for maintaining security of the Client's premises on the following Terms & Conditions.

NOW THIS AGREEMENT WITNESSETH and it is hereby agreed by and between the parties hereto as follow:

1. SCOPE OF WORK:

The Company shall provide following Services:

- a. Carryout study of existing Security Policies, Programs and Practices and developnew policies in fine with the Chent's policy and Rules & Regulations of Government of Sindh
- Enforce and implement revised/approved security program containing effective reporting/monitoring system.
- Assessment of Security manpower requirements of Client in consultation with Client and its administration and develop proposal based on Client vision of lean & efficient security organization.
- d. Provide security to the official / ward's staff, equipment, assets and store inside the Client's premises against threats, pillerage, damage, destruction and theft.
- Maintain peace and order within Client's premises during any disturbance or disorder and emergency.
- Maintain and control traffic thiring peace and emergency, within the Client's premises and parking areas and introduce entry stickers for vehicles/passes as approved by the Client's management.
- Keep 24/7 watch, enforce restriction on unwanted trespusser and addicts with the approval/assistance of the Client's management spot and periodic checks.
- Conduct surveys and security inspection for assessing the security requirement and make recommendation to Client's management.
- Visit of all zones/wards of the Chent's premises for improvement of security services
- Detail discussion with Client's senior management for continuous improvement in security parameters.
- k Provide Security at all time.
- Maintain harmony under stressful situation.
- m Maintain traffic inflow during peace and emergency time and arrange to park the vehicles as per policy of the Client's Administration.
- The Company shall also be responsible to carry out any other job assigned by the Client's Administration in this regard.

2. AREA COVERED

a. The Company is operating on and from the 1° December, 2014 to maintain a Security Services at the following premises, address/location of the Client.



 The Company shall be fully responsible to keep the whole premises secured according to the entire satisfaction of the Client's Administration.

3. OBILGATIONS OF COMPANY, CLIENT AND WORKERS:-

 Company shall tender security services and all matters relevant/incidental thereto ("Services) in accordance with the specification/instructions given by the Client from time to time to Company, for the Client's premises.

Company further agrees to abide by all the terms and conditions stipulated and notified in the Tender / Bid Form. J





- Company, throughout the term of this Agreement shall make Services available to the Client under this Agreement of professional quality conforming to generally accepted standards and practices and shall make its best efforts to ensure almost satisfaction of the Client
- Company shall also ensure to maintain 90% of total numbers of Security Guards / Chowkidars and Security Supervisors everyday according to the sanctioned strength.
 - Security Guards / Chowkidars of the client will be assisted to the Company. In case
 of complaints or absence reported, necessary action will be taken against them by
 the Chent's Administration, as per Government Rules.
 - iii. Client's multiorized officer shall declare sensitive areas and list of Security Guards required for that area and the same will be provided to the Company Phese Security Guards will neither be transferred nor terminated by the Company without taking written permission from the Client.
 - in. The sanctioned strength can be increased / decreased on budget availability basis.
- Company shall submit to the Client's authorized officer Security Services Monthly Bill along with the invoice on 25th of the same month. Client's Additional Medical Superintendent (Security) will verify the bills within three days and submit the same to the Accounts Branch on First (1th) of the succeeding month for further processing and arranging the payment from the office of the Accountant General Sindh by 10th of the month however in case of any reasonable delay occurred towards payment of any invoice the Client shall not be responsible for any late payment surcharge of whatsoever nature or any penalty to the Company and the bill for the month of June will be submitted before date of Closing fixed by the A.G. Sindh.
- In case of any dispute between Security Guards/Workers with the Company, the matter shall be referred to the Client's administration for arbitration whose decision shall be final and binding upon the concerned Security Guards/Workers and the Company.
- Company shall provide duty roster of the Security Supervisors Accordingly to the Client's administration on the monthly basis.
- Company shall ensure that Security Guards/Workers/Security Supervisors involved in immoral and indiscipline activities shall not be allowed to serve under this Agreement and the Company shall refer the matter to the Client.
- Company shall be bound to immediately change the Security Guards/Workers/Security, Supervisors who will be unwanted by the Client's administration.
- Security Guards/Workers/Security Supervisors shall work according to time table issued by the Client's Additional Medical Superintendent (Security), Civil Hospital Karachi.
- Company undertakes that it shall not violate the Child Labour Rules and Basic Human Rights, while performing Services under this Agreement
- Company shall be bound to provide manpower fully in accordance with the present Agreement and in case of any deficiency shall compensate the Client in reasonable manner.
- Company shall be bound to Maintain 90% of the sanctioned strength of Security Guards/Workers/Security Supervisors round the clock at all times even on holidays.
- Company shall ensure provision of appropriate lawful licensed weapons ammunition / communication equipments to Security Guards/Workers/Security Supervisors for safety /security of the Hospital Assets.
- The weapons / ammunition / communication equipments provided by the Company must be get approved by the Client's authorized officer before commencement of agreement.
- Company shall be exclusively responsible for maintenance and security of the weapons
 / ammunition / communication equipments.
- In case of any complaint or observation conveyed to the Company or its supervisor by the Client's authorities / Additional Medical Superintendent, the Company shall report in writing within stipulated time to the Client about the steps taken in order to rectify those observations



- Company shall be fully responsible to keep the premises of the Client secured fully in accordance with the satisfaction of Client's administration and the Company shall be responsible for round the clock security of the areas under this Agreement.
- Company shall not participate in any political / immoral / illegal activities in the Client's premises.
- Neither the Company not it shall allow any Security Guard/Worker/Security Supervisor to violate laws and rules of the Government.
- In every case of whatsoever nature, the Company shall exclusively be responsible for all act affairs / activities and personality of the Security Guards/Workers/Security Supervisors. In addition, the Company shall also exclusively be responsible for any theft or pitterage committed by any of his Security Guard/Worker/Security Supervisor and the said Security Guard/Worker/Security Supervisor shall be liable for punishment under the laws and rules.
- The Company in all cases shall indemnify the Client.
- Company shall ensure that the Security Guard/Worker/Security Supervisor shall work according to day/night shift basis and they will be bound to wear neat and clean uniform and badges approved by the Company. In case of violation fine will be imposed by the Client's Additional Medical Superintendent which will be at least Rs.50/- (Rupees: Fifty Only) per Security Guard/Worker/Security Supervisor per day.

4. CONSIDERATION:

- a. The Client shall pay to the Company a sum of Rs.1,373,500/- (Rupees: One Million Three Hundred Seventy Three Thousand Five Hundred Only) per month, upon issuance of bill of the Security persons as offered in tender by the Company after completion of the month, and in consideration thereof the Company undertakes and promises to render Services under this Agreement.
- b. All payments to the Company shall be paid through Cross Cheque issued by the A.G. Sindh in favour of "M/S. DEFENDER SECURITY SERVICES (PVT.) LIMITED" and subject to deduction of Withholding Income Tax and Stamp Duty will be recovered from Monthly bill of the Company.
- The Company shall be responsible for payment of all the applicable Government Institution's Contribution except withholding tax mentioned in ante clause 4 (b).
- d. The sanctioned strength can be increased / decreased on the basis of the funds, and the payment will be made accordingly.

5. TERM AND TERMINATION OF AGREEMENT

- a. The Agreement for One Year shall be deemed to have commenced with effect from 1st December, 2014 to 30th November, 2015 for a probationary period of Three (03) months and upon completion of the said probationary term continue till 30th November, 2015 extendable a further one year.
- b. During probationary period, the Agreement may be terminated at any time by Client's Medical Superintendent without assigning any reason and issuing any prior notice.
- c. During or Subsequent to completion of probationary period the Agreement may be terminated at any time by either party without assigning any reason subject to Thirty (30) days advance written notice.
- d. In the event of termination of this Agreement under ante clause 5 (b) (c), the Company shall not be entitled to claim any losses or damages from the Client arising out of such termination.

6. ASSIGNMENT:

Either party shall not be entitled to transfer its rights or duties under this agreement to any other party.

LAW:

This agreement shall be governed by and construed in accordance with the laws of Pakistan. Nothing contained herein shall contravene any prevailing or prospective laws relating to the parties.

No addition, amendment, variation or modification to any of the terms of this agreement shall be valid and binding unless made in writing signed by and on behalf of both the parties itself or by their duly authorized representatives.

9. ENTIRE UNDERSTANDING:

This agreement constitutes the entire agreement between the parties and supersedes all other representations or prior agreements (if any), all proposals, whether oral or written, relating to the provisions of this agreement between the parties.

10. NOTICES

All notices required to be given or information supplied by other of the parties to other pursuant to provisions of this agreement must be in writing and shall be sent by registered post / counter service or personally served or by telefax with a copy sent by registered post / counter service to the parties addresses specified at the front of this agreement or to such other address or telefax number as may from time to time be notified in writing by either of the parties to other, and any notice delivered by registered muil to have been served on the third (3rd) day after the date on which it is posted and any notice sent by telefax on the date on which such telefax is transmitted. Notice is effective upon confirmed receipt.

11. HEADINGS:

The headings of the clauses of this agreement being for convenience only shall not effect the construction thereof.

12. RELATIONSHIP OF PARTIES:

This agreement does not create a joint venture or partnership between the parties and each will act independently of the other. Neither party is empowered to bind or commit the other to any agreement or other obligation.

TEXT:

This agreement is written in English version with two copies, one for each party Both copies have the same effect.

14. CONFIDENTIALITY:

That the Company, including its employees, shall be bound not to disclose or divulge to others or any third party or use either during or after termination of this agreement, any business, technical or other information or whatsoever nature terms of this agreement. None of the information will be given to any third party without the prior written consent of the Client.

15. FORCE MAJEURE:


Neither party shall be liable to the other for any failure or delay in the performance of its obligations under this agreement due to circumstance, which constitute force majeure events beyond their control.

16. ARBITRATION:

In the event that there shall be any dispute or difference between the parties as to this agreement or any matter relating hereto the Company shall first approach the Client's Additional Medical Superintendent (Gen) for attempting to resolve the dispute or difference amicably and in the event this shall not prove possible such dispute or difference shall be referred to Client's Medical Superintendent for arbitration who shall be sole arbitrator and his decision shall be final and binding on the parties bereto

17. PENAL CLAUSE

a. In case of violation of any term of this, Agreement, the Company should be fined upto Rs.1,000/- (Rupees One Thousand Only) at one time and legal action can be initiated against it by the Client.





b. In case of breach of this Agreement by the Company, security will be forfeited partly or fully as decided by the Chent's Medical Superintendent Civil Hospital Karachi.

GENERAL: 18.

- a. The failure on the part of either party to exercise any right conferred upon him or it by this agreement shall not be deemed to be a waiver of any such right or operate so as to bar the exercise or enforcement thereof at any time or times thereafter.
- b. This agreement shall not confer any right of suit or action whatsoever to and on any third party.
- c. This agreement is non-exclusive and the parties are at liberty to initiate and contract similar types of agreement with any other party without involving the other party under this agreement.
- d. The language for the purpose of administering and interpreting this agreement including any Proceedings bereunder shall be English.
- Further commitments in addition or in further detail to the above may be the subject of an additional agreement between the parties in the future.
- f. Any condition / clause of the Company can be included / amended if required in the interest of the Client with the mutual understanding of both the parties.
- g. In case of breach of the agreement by the Company, its security shall be forfeited partly or fully as decided by the Client's Medical Superintendent.
- Call deposit of the successful bidder will be transferable to security account.






