- Although there are many makes of polyurethane soling machine, this specification only allows one make (Desma) to be qualified. Only one manufacturer is using Desma in the country so intent of this clause is clear.
- The sole design (Sierra) is also only made by the same manufacturer so the intent becomes even clearer.
- The toc-puff material/Stiffener material and binding is also mentioned by brand name whereas this should be generic.

ii. M/s. Hussain Enterprises.

"Complainant stated that the specification of DMS boot is violation of Sindh Public Procurement Rules 2010 clause no. 13 under the heading of "Specification" which clearly mentions that "Specification shall be generic and shall not include references to brand names, model number, catalogue numbers or similar classification". Whereas the specification given with the bid documents of DMS boots clearly violating the above mentioned rules as the department requirement is "PU/Rubber-Double Density Sole – Direct Injection", however the department has also mentioned that this sole shall be made on DESMA Machine whereas this technology can also be easily made on other machines available in market. Furthermore, this cannot be tested in any laboratory that from which machine the sole is made off. However the testing laboratory will only determine that whether the sole of DMS boot has developed is of "PU/Rubber Double Density Direct Injected" or not. This particular name of machine is clearly in violation of SPPRA rules 2010 clause no.13 under the heading of "Specification" which clearly mentions that "Specification shall allow the widest possible competition and shall not favor any single contractor or supplier nor put others at a disadvantage"

iii. M/s. Zafar Azfar & Co. (did not attend) his written complaint is as under:-

"Complainant stated that there are so option to manufacturer boot DMS but your specification shows PU sole with specific machine i.e. DESMA. Sole design (Sierra) is also indicate to a specific manufacturer who is already develop this".

- 4/- The committee observed that the above firms have participated in DMS boot for Sindh Police and recommended the following points:-
 - Lab test of each pair.
 - DESMA machine is wave off in Specification of DMS boot.
 - iii. Re-tender of DMS boot for Sindh Police.
