



The Committee was informed that a tender notice was got published in leading newspapers; Daily Dawn (English), Daily Kawish (Sindhi) and Daily Jang (Urdu) on 28.12.2017. The same was hoisted on the website of BIE, Karachi and as well as SPPRA at serial No. 36010. According to SPPRA Rules, Single stage - two envelopes bids, containing Technical and Financial Proposals, were invited for the purpose.

In response to advertisement, seven (07) firms participated and submitted their Bids (Technical & Financial Proposals), out of which following three (03) firms were found preliminary technically qualified by the Committee:

- M/s. Z.A Corporation, Lahore
- M/s. Benison Printers, Karachi
- M/s. Paradise Printing, Press Karachi

Accordingly, the Procurement Committee opened the Financial Proposals of the technically qualified bidders in presence of bidders or their representatives. The amount of Bid Security and the item wise rates quoted by firms were read-out and announced loudly. A detail of comparative statement showing article wise rate was prepared and is annexed with the minutes at "A". The required bid security @ Rs.3% of bid price was found intact in respect of the following firms:

- M/s. Z.A Corporation, Lahore (P.O No 0234504, 0234505 & 0234506 Rs.410,000/-)
- M/s. Benison Printers, Karachi, (P.O No.12062173 & 04487516 Rs.300,000/-)
- M/s. Paradise Printing, Press Karachi, (P.O No. 03808177 Rs.500,000/- 13785206 Rs.200,000/- & 13785207 Rs.200,000/- total RS.900,000)

During the announcement of item wise rates, the committee was observed that the bidders have quoted rates for Articles # 01, 02, & 03, of ASL & Syed Paper Mills. Hence, the committee examined the last year answer scripts to evaluate and compare the quality of paper with the samples provided by the bidders. Observing the standard of papers and satisfying with the quality, committee decided to accept the rates for ASL papers.

Committee was informed that as per the terms & conditions given in the bidding document, the firms have to complete the supply of stores with regards answer script be provided within 60 days and remaining items shall supplied within 90 days period excepting tabulation register be supplied as per requirement of the store. Accordingly, on delivery of stores, the same would be required to be inspected by the Inspection Committee of the Board in accordance with approved sample.

Keeping in view of the necessity of required articles, committee emphasized to complete the delivery of stores within stipulated period as mentioned above, as also defined in the bidding documents and decided that the respective Inspection Committee must ensure the inspection of stores in accordance with the samples of articles approved by the procurement Committee.

The detailed comparative statements for items were prepared by the Committee and the same are attached with minutes as Annexure "B". The summarized position of the Financial Proposals is given as follows:-
