MINUTES OF THE MEETING OF PROCUREMENT COMMITTEE HELD ON
10-05-2016 AT 2.30 P.M. FOR THE YEAR 2016-2017

1. The Regional Directorate of Food, Larkana / Procuring Agency invited bids for opening the same on 10-05-2016 from the interested parties for Transportation of Wheat / Bardana & Miscellaneous work etc. for within District & other District for the period upto 28-02-2017 for the year 2016-2017 vide this office Tender Notice No.AC/Tender-2016-2017/553 dated 25-03-2016, and which were published in daily Wake dated 30-03-2016, Dawn, Express, Millan dated 31-03-2016, Hilal-e-Pakistan dated 01-04-2016 & Kawish dated 02-04-2016.

2. The tenders were opened on 10-05-2016, the meeting started with Tilawat of Holly Quran in presence of the concerned parties or their representatives and following members of the procurement committee constituted under the Rules framed by SPPRA and as per orders of the Head of the Department.

3. 24 (Twenty Four) Blank tender forms were issued up to 09-05-2016 alongwith details of work and the amount of security deposit shown in the bidding documents. Out of which 34 (Thirty Four) envelopes were received on 10-05-2016 within the fixed time in which 10 (Ten) Technical Proposals and 24 (Twenty Four) Financial Proposals were found.

4. All 10 (Ten) Technical Proposals were opened in presence of the above committee members and the concerned parties or their representatives which have been examined case to case and found complete / qualified.

5. After finalizing the technical proposals, 10 (Ten) parties (bidders) have been qualified and those 10 (Ten) party's (bidder's) financial proposals were opened. From 24 (Twenty Four) Financial Proposals (envelopes), 24 (Twenty Four) filled tender forms were found out of which 7 (Seven) Routes were found without Security Deposits, hence the same were not considered.

6. However, the necessary comparative statement was prepared then & there in the presence of all the above members and parties. As per procedure, the rates were read over loudly and clearly.
