I. Chundrigar Road, Karachi on **"21-10-2014 at 1030 hours"**.
4. The tender shall be opened on **"21-10-2014 at 1100 hours"** in presence of Purchase Committee and representatives of bidders who choose to be present on the occasion in the Committee Room of Central Police Office, Sindh, Ground Floor, I. I. Chundrigar Road, Karachi.
5. Only manufacturers / authorized distributors / authorized dealers registered with Income Tax and Sales Tax Departments are eligible to participate in the tenders. (Documentary proof required)
