Total 63 Nos. of tenders documents were found in the tender box for different works. The following firms participated in the tenders. The names of bidders and their offered bids were called out loudly for each work to let the participants know the quoted price fairly. There found no correction in submitted bids and participants got attentive in this respect.

The Committee scrutinized all the tender documents and narrated quoted bids in a comparative statement. After computation of bid prices it was verified that the 1st lowest contractors' rates are feasible as per market position and also within the ceiling/premium fixed by the Government. The Committee recommended the lowest bids for approval and the Chairman accordingly approved the same as under:-
