





may kindly be recommended to Purchase Committee for approval in favour of lowest Bidders provided the items fulfill the required specifications.

It was also decided that the few selected items for which no any firm has offered the rate may also be recommended and placed before the Procurement Committee for kind approve from local market on competitive rates by obtaining quotations on need bases.

The committee also decided that the items of various firms who have participated in the tenders offered the rates of Medicines, Vitamins etc are patent & specific in nature and have failed to produce Registration Certificate of the quoted items with Ministry of Health Government of Pakistan and Authority of the Manufacturer / Sole Agent / Distributor may also be rejected.
