1. The meeting of Procurement Committee Sayed Abdullah Shah Institute of Medical Sciences Sehwan for opening of bid for procurements of medical instruments, equipments, machinery, furniture & fixture and hardware (computer accessories) was held in the committee room of SASIMS Sehwan on 22nd May 2017 at 12:00 PM.
2. The meeting started with recitation of Holy Quran.

4. Chairman welcomed all participants for participating in tender process.
5. The agenda of meeting was opening of Technical Envelopes (one stage two envelopes method) of tender process for procurement of medical instruments, equipments, machinery, furniture & fixture and hardware (computer accessories).

7. Bids were received under one stage two envelope method in two boxes on each for Technical Envelope and Financial Envelope upto 12:00 PM.
8. The box for Technical Envelope was opened at 12:30 PM and envelopes were desealed.

Their financial envelopes were not opened and informed to participants.

The representative of Asfand Traders Hyderabad insisted that his financial proposal should be opened and considered, as by mistake the tender documents could not be included in the technical envelope and items could not be quoted in the technical proposal. After lengthy discussion the committee unanimously reached the conclusion that without tender document and without knowing the details of quoted items his evaluation could not be made and required specification could not be assessed as per SPPRA Rule 42. Besides that he has also been officially communicated regarding his disqualification, therefore his financial proposal cannot be opened and evaluated at this stage. His objection was thus over ruled by the chairman. However the participant refused to receive back his financial proposals.

The representatives of remaining four disqualified bidders namely:

- a) Hospicare System Karachi
- b) Sindh Medical Store Karachi
- c) Seico Scientific Karachi
- d) Fresenius Medical Care Karachi,

who were pre-informed regarding their disqualification did not attend the meeting.

10. The financial envelopes of all other bidders were opened and checked in the presence of participants.
11. The rates quoted by different firms were compared. The comparative statement annexured 1 to 80-B indicate the rates quoted by different firms along with country/origin in different items. It also indicates the lowest evaluated and approved rate.
12. As per their comparative rates the lowest one has been approved by the committee in accordance to SPPRA Rule 46 sub section-4b (III).
13. After evaluation criteria the rate of items which were quoted by the single bidder without other competitors were evaluated on market based rates and was thus approved as single competitor winner.
14. The table annexed as-C indicates the winner firms whose rates has been found lowest in different quoted serial No. items.


