


FORM OF CONTRACT AGREEMENT

THIS CONTRACT AGREEMENT (hereinafter called the —agreement) made on the 24th day of December, 2014 between the Sindh Revenue Board (hereinafter called the procuring Agency) of the one part M/s Technology Manpower Associates (hereinafter called the — contractor) of the other part.

WHERE AS the procuring Agency is desirous that certain works, viz Refurbishment and Interior designing should be executed by the Contractor and accepted a bid by the contractor for the execution and completion of such works and the remedying of any defects therein.

NOW this Agreement witnesses as follows:

- In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the conditions of Contract hereinafter referred to.
- The following documents after incorporating addenda, if any, except those parts relating to Instructions to Bidders, shall be deemed to form and be read and construed as a part of this Agreement, viz:
 - (a) The Letter of Acceptance
 - (b) The completed Form of Bid along with schedules to Bid
- (c) Conditions of Contract & Contract Data
- (d) The Drawings
- 3. In consideration of the payments to be made by the Procuring Agency to the Contractor as hereinafter mentioned, the respectively assigned to them in the conditions of Contract, Contractor hereby covenants with the Procuring Agency to execute and complete the Works and remedy defects therein in conformity and in all respects within the provisions of the contract.
- 4. The Procuring Agency hereby covenants to pay the Contractor, in consideration of the execution and completion of the works as per provisions of the contract, the contract Price or such other sum as may become payable under the provisions of the contract at the times and in the manner prescribed by the contract.



The following definitions shall apply to this Agreement, unless, context otherwise requires, words importing the singular include the plural and vice versa, wherever the context requires.

- 1.1 "Agreement" shall mean this agreement including schedules and annexes attached hereto and any amendments made in writing with mutual consent of the parties.
- 1.2 "Representative" shall mean any person or class of persons authorized by Chairman SRB in writing to co-ordinate and deal with the Interior Designers/Contractors on behalf of the Sindh Revenue Board.
- 1.3. "Services" shall mean the services to be provided by the Interior Designer/Contractor as specified in the Scope of works attached as scheduled "A" to this agreement.
- 1.4 "Work Order still mean any written order/instructions issued by Debas Comyok toner (F&A) SRB to Interior Designer/Contractor in time regular for availing the Services and such Work order(s) details, including but not limited to quantity and the design of the services.

ARTICLE 2. SCOPE OF WORKS.

The Interior Designer/Contractor shall provide the Contractual Services to SRB according to the specification, description as per Scope of Work, mentioned in the tender/bidding document. The Chairman SRB shall have the right to change the

scope of work from time to time and the same changes shall be notified to the vendor and be binding on the Vendor.

Article 3, Business Integrity

The Interior Designer/Contractor shall act in accordance with the provision of this Agreement and rules and policies of SRB and shall deposit;

- (a) An amount equal to 10% of the bidding price/value in the mode of Pay Order/Demand Draft/Bank Guarantee for the validity period of 160 days in favor of "Sindh Revenue Board" on account of Performance Security within thirty days of issuance of the work order.
- (b) Ensure that the Services are well performed in accordance with the international standards of care and diligence normally practiced in performing services of similar nature.
- (c) Conduct business in an ethical manner;
- (d) Comply with the provisions of applicable laws,

The Contractor shall ensure that the Services are performed in such a manner that it shall safeguards and protects the interests of procuring Agency and takes all necessary and proper steps to prevent abuse or uneconomical use of facilities made available by SRB to the Contractor.

The Contractor shall not enter into any agreement with any party conflicting Procuring Agency and if need be after prior written permission of SRB.

That Interior Designer/Contractor will allow Procuring Agency's Representatives upon giving reasonable prior notice to enter into the premises of the Interior Designer/Contractor.

Article 4. Payment/Charges for Services

4.1. The consideration for provision of the Services and for the fulfillment of Other obligations under this Agreement, Sindh Revenue Board shall subject to the provision of the Agreement, pay or cause to be paid to the Contractor the charges in accordance with the rates stated in the schedule "BOO".

The payment will be made on basis of work done which would be verified by the XEN/Engineer of the Work & Services Department, Government of Sindh of the Procuring Committee of Sindh Revenue Board or/and on the satisfaction of work done or on the genuine requirement for finishing the work, by the approval of the Competent Authority of the Sindh Revenue Board.

- 4.2 The charges/rates for the services shall remain unchanged during the period of this Agreement unless the Parties mutually agree in meeting the charges in charges/rates.
- 4.3 The charges/rates for the services shall be inclusive of all taxes (sales tax), expenses, transpiration cost to be incurred by the Contractor for provision of Services to SRB.
- 4.4 Except in case of discrepancies in the invoices(s) submitted by the Contractor to the DC/EAA) SRB, payment to the Contractor will be made after (10) days from the submission of invoice supported with documents or idencing the receipt of the Services by the SRB's Representatives only few approval of the Competent Authority.

 4.5 The DC(EAA) SRB are receipted to the Competent Authority.
- 4.5 The DC(F&&) SRB may instruct/direct the Contractor to carry out any additional workesapely of good for completion of the project not envisioned at this stage. The rates of the additional work/items shall be mutually agreed.

4.6 TAXES

Income Tax and Sales Tax on the Services on which sales tax is applicable shall be withheld at source by the DC (F&A)/DDO, Sindh Revenue Board as per Law.

4.7 PENALITY CLAUSE (LIQUIDITY DAMAGES AS PER SPPRA CONDITIONS)

- In case of delay without having any reason or justification to the Competent Authority, beyond the specified period i.e. 2 months from the date of issuance of work order for the completion of the contract/ agreement, the Sindh Revenue Board will reserve its rights to charge liquidated damages at the rate of 0.10% per day of the bidding amount and 10% of the contract price/value in the letter of acceptance and also charge per day rent amount of the work area (which will be calculated in square feet).
- In case of early and satisfactory completion of the work the contractor shall be entitled to reward at the same rate as mentioned in clause 1 above.

ARTICLE 5. VENDOR AND EMPLOYEE

5.1 The workers and staff employed of the Contractor for provision of services to SRB under this agreement shall be Contractor's employees for all purposes and the Contractor shall be responsible for their numbers, wages terms & conditions of the service and other liabilities which may occur under law of the land.

Such workers shall not in any manner be liable of the SRB on any account what so ever and anything done by them or any act or omission on their part shall be the liability of the contactor.

- 5.2 The contractor shall be responsible for any liability legally conferred on the employees or vicariously on the Contractor and shall complete all the legal liabilities as per law.
- 5.3 The Contractor shall be responsible to observe labor laws in enforcement operation, enforce at the present and may be enforced from time to time.

If there is any fault, contravention, differences, disputes or any matters or clams to arise relating to any right or benefit allowed or available to employees / persons / personnel of the contractor, the same shall be claimed from and paid / allowed by the contractor who maintains the required record and holds registration in this regards.

- 5.4 It is specifically agreed and understood that the relationship b/w Procuring Agency and the Contractor is of the purchaser and seller; and Contractor in relation to this agreement shall not be the employee/workman of the SRB for any purpose, whatsoever.
- 5.5 The interior designer / contractor specifically undertakes that it shall not engage / hire / employee, child labor, while discharge its contractual duties hereunder. Procuring Agency shall have the right to inspect the premises of the manufacturing facilities of the Contractor to ensure that the contractor is complying with the provision of this Agreement and all relevant laws.
- 5.6 The Contractor shall ensure that its employees are not involved in any manner in any criminal offence on convicted or using or possessing drugs, unprescribed medicines a substance in order to ensure the above stated, the Contractor shall be responsible to maintain complete record of its employees including verification of references and following screening procedures before hiring / engaging its employees.

ARBITRATION

5.7 Any dispute, if arising out of the contract, shall be referred to a sole arbitrator to be appointed by Procuring Agency and the decision of the arbitrator shall be final and binding on both the parties.

ARTICLE 6. INDEMNIFICATION

- 6.1 The Contractor shall hold harmless and indemnify Procuring Agency from any action, damages and claims. Whatsoever, either at law or in equity, judgments including cost and legal fees which may be rendered against Procuring Agency arising from any incidence, referred to in article 5 above.
- 6.2 SRB shall not be liable in any manner for any injury or death of the any Contractor's employee / staff / agent or representative suffered while in Procuring Agency premises or anywhere else while performing the services under this agreement and including without any limitation for any damages suffered which result malfunction of any equipment.
- 6.3 The Procuring Agency shall be entitled to damages against any loss or damage occurred to the interest of Procuring Agency or the overall structure of building, incident, fire, or any other adverse happening attributable to Contractor or its employees, agent's or any person working on his behalf.

ARTICLE 7. WARRANTY

7.1 The Contractor warrants and guarantees that the services shall be of good standard and quality and shall comply in all respect with the specifications as mentioned in this agreement

ARTICLE 8. TERMS AND TERMINATION

- 8.1 This agreement shall be valid in full force and effective for a period of 2 months effective from commencement of works i.e. 24th December, 2014.
- 8.2 The Procuring Agency reserves its right to terminate this contract immediately at its discretion without any implications and notwithstanding the terms herein, in case of breach of the contract or may at its discretion refer the matter to arbitrator. Inordinate delay in performance shall be misconduct within the meaning of the agreement.
- 8.3 The Contractor may also terminate this agreement by giving a reasonable notice and reason of its inability to perform this agreement due to force, majeure, natural calamity, but shall not terminate the agreement due to its in-capacity, in-expertise, in-efficiency to perform and anything amounting to its own disability or any other reason not beyond the reasonable control of the Contractor.
- 8.4 Notwithstanding articles 8.1 to 8.3 The Procuring Agency & Contractor, with mutual consent shall have right to terminate this Agreement.

ARTICLE 9. OWNERSHIP RIGHTS

- 9.1 The Contractor small not use any trade names/marks, logos and other properties belonging to Procuring Agency under Authority's specifications in intellectual by the management of SRB.
- 9.2 All documents and information given to the Contractor by the Procuring Agency shall remain absolute property of SRB.

ARTICLE 10. FORCE MAJEURE

- 10.1 Subject to provision of this article, no party to this Agreement shall be liable for any failure to fulfill its obligations or any term of this Agreement or any omission to carry out or observe any stipulation term of this agreement if fulfillment has been delayed, hindered, interfered with or prevented by any circumstance, which are not within the control of the party in question including not limited to compliance with any Government authority, act of warm sabutage, acts of God which by the exercise of reasonable diligence such party within seven days of the occurrence of such event. For the duration of the effect of such circumstances beyond their control, the parties hereto shall be released from their respective obligation hereunder to the extent such obligation can not be performed as result of such circumstances.
- 10.2 Among other events, an event shall be deemed to be within the control of the Contractor if:
- (a) It is strikes, labor or employment dispute, or difficulty or other concerned acts of workmen whether direct or indirect among the employees of Contractor or any of its sub-contractor.
- 10.3 Force majeure shall not include any event if it is due to non-compliance with any applicable law.
- 10.4 On the occurrence of any event of force majeure the party affected shall.
 - (a) Give written notice of such an event to the other party and promptly confirm that notice by letter fax.
 - (b) Use reasonable endeavor to mitigate the effect upon fulfillment of its obligation under this Agreement and resume full performance of such obligation hereunder.

ARTICLE 11. ASSIGNMENT/SUBCONTRACTING

The Contractor shall not be entitled to assign either in whole or in part any of its rights and obligations under this Agreement without the prior written consent thereto of the DC (F&A) of SRB. The Vendor shall not sub-contract its obligation under this Agreement to third parties without prior written permission of DC (F&A), SRB.

ARTICLE 12. COMPLIANCE WITH LAWS

Each party acknowledges and agrees that the confidential information received by it from the other party shall be strictly confidential and shall not be disclosed or revealed to any person other than those employees of such party who needs to know the confidential information for the purposes of performing their respective obligations under this agreement and such employees shall take appropriate steps to keep secrets an information provided to them. The obligation of the Contractor under this article shall remain valid and in full force even after termination of this Agreement. For the purpose of this article the confidential information shall include but not limited to the provincial perfaining to the business and operations of SRB and information elifting to its customers. And the Contractor shall return all documents information shall be offensive, when without the knowledge of the SRB.

ARTICLE 14. WAIVER

A waiver on the part of DC (F&A) SRB or Contractor of any breach of any team or any term, provision or condition of this Agreement shall not constitute a precedent and shall not bind either party hereto to waiver of any succeeding breach, provisions or condition of this Agreement.

ARTICLE 15. APPLICABLE LAW & JURISDICTION

The validity, application, interpretation and implementation of this Agreement and any dispute controversy and claim shall be governed jurisdiction of and arbitration by the laws of Pakistan. The Parties shall submit to the non-exclusive courts in Karachi, Pakistan.

ARTICLE 16. PROCURING AGENCY'S LIABILITY

All obligations accruing out of this Agreement are only attributable and are responsibility of SRB, subject to the laws of Pakistan and no other affiliate or associated undertaking of SRB, or Government of Sindh shall be responsible in any manner whatsoever.

ARTICLE 17. NOTICES

Thereafter, a letter bearing No.Dir(Enf-II) SRB-02(N)/SPPRA/14-15/4092 dated 19th September 2014 (Annex-VI) of Manager (Enf-II) of SPPRA was received to this office against the said SRB's advertisements
