Only two firms i.e. M/s Interwood Mobel and M/s Torch Office Systems obtained bid documents for the items mentioned at S.No.6 to 25 and 01 firm i.e. M/s Shaheer Traders obtained bid document for the item at S.No.20, but firm i.e. M/s Interwood Mobel submitted their bids for the items mentioned at S.No.6 to 25. Whereas M/s Shaheer Traders submitted their bid for the item at S.No.20, which was rejected by the Procurement Committee as it was not as per specification. The Procurement Committee compared the quoted prices by M/s Interwood Mobel from the market and from the website. The Committee does not compare the quoted price from the rates of the last awarded contract because the same quality of furniture was not procured previously by Sindh Police except for ongoing procurement. The Committee is of the view that quality/durability of the quoted items by the said firm is reliable which include after sales support. Therefore the Procurement Committee decided to accept the bids in which only single firm qualified as per condition mentioned in Rule-48 of SPP Rules 2010 (amended 2017).
