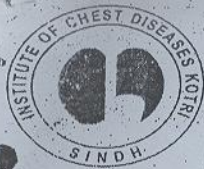



Para No's:-

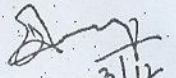
- The observation noted in Para (a) i.e Lenin items Sr. No.09, 22, 24 and few miscellaneous items like Soap and detergent items has been given with the brand names and without using the words " or equalent " have been noted for the future in terms of rule 13 (I) of SPP rule 2010.
- Regarding procuring Lenin and Uniform items the word used as best quality instead of sample. In our opinion the cloth given as sample were of best quality, hence best quality and sample is the same in the view of Tender Committee, however in the future this has been noted and will not be repeated again.
- In case of Dietary items like cooking oil and Tea Leaves have been procured, using the brand names. The purpose of procuring the diet items like cooking oil and Tea was to purchase the known best quality in the market. However this is noted for future. Moreover the bid for item No.3 i.e breakfast Bread have been accepted at Rs.43.98 750gm. It is not possible for any body to quote Rs.8.49 750gm lowest price because of hike in market rates this was typing mistake in Comparative statement, as the party No. 01 has not quoted the rate of bread.(Tender copy is attached).

  - 1.3 The tenders must be free from erasing, cutting and over writing. In case of erasing, cutting and over writing, authorized person should initial it.
  - 1.4 The rates of each item should be written in figures as well as in words. Arithmetical errors will be rectified on the basis: if there is discrepancy between the unit price and the total price that is obtained by multiplying the unit price and the quantity, the unit price shall prevail and the total price shall be corrected. In case of discrepancy the price in words will be taken as authenticated and final.
  - 1.5 Conditional Tenders will be ignored and will not be considered / entertained / accepted.
  - 1.6 Tenders from both Registered and un-registered firms shall be accompanied by Earnest Money @ 2 ½ % of the value of Stores quoted by them in form of Call Deposit/ Pay order.

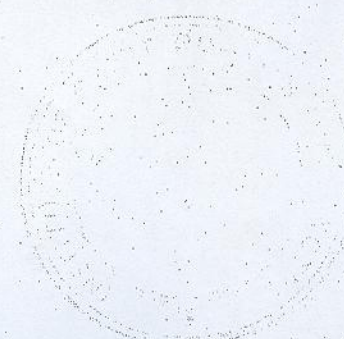
