

So, their tender bid of M/s: Sharp Security Services (Pvt) Ltd., was rejected by the Procurement Committee on same day and also intimated to the re-representative of M/s: Sharp Security Services (Pvt) Ltd., during meeting.

4). The 2nd meeting was held on 25th June, 2016 at 11:30 AM in the Committee Room for Technical evaluation/scrutiny of documents of technical bid. It is observed that M/s: Defender Security Services (Pvt) Ltd have not submitted copy of current renewal certificate from Home Department, Government of Sindh which was expired on 31/12/2015 according to tender

requirement, during the meeting representative of M/s:Defender Security Services (Pvt) Ltd requested to give time for the submission of same within 72 hours, due to Home Department is closed i.e. Saturday & Sunday. After detail deliberation/discussed the technical bid of M/s: Defender Security Services (Pvt) Ltd was rejected by the Procurement Committee and financial/Commercial bid also returned without opening.




