A meeting of Procurement Committee of Mobile Emergency Health Care Unit (MEHCU) Project was held on 09.03.2015 under the Chairmanship of Project Director, MEHCU Project / Chairman, Procurement Committee in the office of Secretary, Special Initiatives Department Government of Sindh regarding opening the financial bids / proposals for purchase of Mobile Emergency Health Care Units for MEHCU Project.

The Chair welcomed the members of Procurement Committee and representatives of bidders and briefed them that after comprehensive evaluation the technical proposals of following two firms were found responsive as they met the requirements of the evaluation criteria and specification set-forth in the bidding documents, therefore their financial proposals were being opened today.

The Representative of Finance Department / member of Procurement Committee opined that as the funds were not yet been released by the Finance Department, therefore, procurement process should not be initiated. The Chairman / Project Director explained that the project is approved by the PDWP and Administrative Approval (A.A) stands issued, D.R.O has also been submitted to Finance Department which is in process of approval. The Finance Department has also accorded approval for opening of assignment account. He further briefed that the procurement process has been started in order to save time, so that the project is launched in current financial year i.e. 2014-15 and allocated funds are also utilized in time to avoid its lapsing. This time management was necessary to complete the project within its stipulated execution period otherwise there will be enhancement in execution period alongwith cost escalation.

The representative of Finance Department agreed to open the bid but desired that the result should be declared with the condition that the agreement with selected bidder should be signed after release of funds from Finance Department. The Committee agreed with this suggestion of representative of Finance Department.

Thereafter, the financial proposals of above two firms were opened before the members and representative of bidders.





